The Mayor and Council of Brunswick shall have the power to pass Ordinances and to fix fines, not to exceed IOne Hundred Dollars - \$100.001 ONE THOUSAND DOLLARS - \$1,000.00 in any one case, for a violation of any of the Ordinances of the Town. In case of non-payment of any such fines, they may provide by Ordinance for the confinement of the party failing or refusing to pay such fine in the ITown Lockup or thel County Jail for a period not exceeding ninety (90) days for any single failure to pay a fine. All fines, penalties or forfeitures imposed by this Charter or any Ordinance of the Mayor and Council may be recovered in the name of the Mayor and Council of Brunswick before a ITrial Magistrate I JUDGE OF THE DISTRICT COURT OF MARYLAND, as small debts are recovered, and the money arising therefrom shall be paid to the Mayor and Council for the use of the Town.

AND BE IT FURTHER RESOLVED, that a complete and exact copy of the aforegoing Resolution be posted at the Brunswick City Hall for a period of at least forty (40) days commencing on January 11, 1972; and that a fair summary of the aforegoing Resolution be published in the Frederick News-Post at least four (4) times at weekly intervals during the aforesaid forty (40) day period: and the aforegoing Resolution shall become a part of the Municipal Charter of Brunswick on the fiftieth (50th) day following its adoption unless a Petition requesting a referendum on the matter is submitted to the Mayor and Council of Brunswick on or before the fortieth (40th) day following the adoption of this Resolution, in compliance with the Provisions of Article 23A Section 13 of the Annotated Code of Maryland (1957 Edition and its Supplements).

ORDINANCE NO. 298

AN ORDINANCE TO REPEAL AND RE-ENACT WITH AMENDMENTS SECTION 3 OF ORDINANCE NO. 247 OF THE TOWN OF BRUNSWICK, MARYLAND, TITLED "AN ORDINANCE TO MAKE IT UNLAWFUL TO FIRE, DISCHARGE OR SET OFF ANY DANGEROUS WEAPON OF ANY CHARACTER WITHIN THE CITY LIMITS OF THE TOWN OF BRUNSWICK, PROVIDING **FOR PERMIT** Α THERFORE, PRESCRIBING THE PENALTIES FOR THE VIOLATION OF THE SAME" SO AS TO REDUCE THE FINE FIXED FOR VIOLATION THEREOF FROM FROM "NOT TO EXCEED THREE HUNDRED DOLLARS -\$300.00" TO "NOT TO EXCEED ONE HUNDRED DOLLARS - \$100.00" OR BY IMPRISONMENT IN THE COUNTY JAIL FOR NOT MORE THAN SIX (6) MONTHS OR BY BOTH SUCH FINE AND IMPRISONMENT IN THE DISCRETION OF THE COURT.

BE IT ENACTED AND ORDAINED BY MAYOR AND COUNCIL OF BRUNSWICK, that Section 3 of Ordinance No. 247 of the Town of Brunswick, Maryland, titled "An Ordinance to make it unlawful to fire, discharge or set off
