

NORMAL BUSINESS HOURS. THE CORPORATE LIMITS SHALL INCLUDE ALL THE TERRITORY WITHIN THE FOLLOWING LIMITS:

(A) THE CORPORATE LIMITS OF SAID TOWN SHALL BE DEFINED AND LAIN OUT ON PLAT OF OTWAY B. ZANTZINGER'S SUBDIVISION, KNOWN AS CAPITOL HEIGHTS, RECORDED IN LIBER J.W.B. NO. 5, FOLIOS 676 AND 677K OF THE LAND RECORDS OF PRINCE GEORGE'S COUNTY, MARYLAND.

(B) 1951 ANNEXATION. THE BOUNDARIES OF THE TOWN OF CAPITOL HEIGHTS ARE HEREBY EXTENDED TO INCLUDE THE FOLLOWING AREA IN PRINCE GEORGE'S COUNTY, WHICH IS HEREBY ADDED TO SAID TOWN:

BEGINNING FOR THE SAME AT A POINT AT THE INTERSECTION OF THE SOUTH LINE OF BROOK ROAD AND THE WEST LINE OF THE SUBDIVISION OF CAPITOL HEIGHTS, AS RECORDED AMONG THE LAND RECORDS OF PRINCE GEORGE'S COUNTY AND THE RUNNING THENCE WITH THE SOUTH AND WEST LINE OF BROOK ROAD (30 FEET WIDE):

 S. 32° 51' 40" E. 101.49 FEET
 S. 37° 08' 40" W. 235.14 FEET
 S. 14° 22' 00" W. 235.14 FEET
 S. 16° 28' 00" W. 898.45 FEET
 S. 13° 44' 30" W. 197.86 FEET TO A POINT ON THE NORTH LINE OF THE PROPERTY OF THE WASHINGTON SUBURBAN SANITARY COMMISSION AND THE RUNNING THENCE WITH SAID WASHINGTON SUBURBAN SANITARY COMMISSION LINE.

N. 77° 36' 40" W. 600.42 FEET TO A POINT IN THE EAST LINE OF LOT 8, BLOCK 39 "GREATER CAPITOL HEIGHTS" AND RUNNING THENCE WITH THE EAST LINE OF GREATER CAPITOL HEIGHTS.

N. 22° 25' 50" E. 105.67 FEET TO A POINT COMMON TO BLOCK 46, CAPITOL HEIGHTS AND BLOCK 39, GREATER CAPITOL HEIGHTS AND RUNNING THENCE WITH THE EAST LINE OF CAPITOL HEIGHTS.

N. 22° 25' 50" E. 1570.43 FEET TO THE POINT OF BEGINNING; CONTAINING 17.553 ACRES.

RESIDENTS. ALL OF THE INHABITANTS OF THE TERRITORY BY THIS SECTION ANNEXED TO THE TOWN OF CAPITOL HEIGHTS SHALL IN ALL RESPECTS BE SUBJECT TO THE POWERS, JURISDICTION AND AUTHORITY NOW VESTED OR TO BE VESTED BY LAW IN THE MAYOR AND COMMON COUNCIL OF CAPITOL HEIGHTS.

LAWS APPLICABLE. ALL THE PROVISIONS OF THE PUBLIC LOCAL LAWS OF MARYLAND PERTAINING TO THE TOWN OF CAPITOL HEIGHTS AND ALL OF THE ORDINANCES HERETOFORE ENACTED BY THE MAYOR AND COMMON COUNCIL OF CAPITOL HEIGHTS ARE EXTENDED AND MADE APPLICABLE TO THE TERRITORY BY THIS SECTION ANNEXED TO SAID TOWN OF CAPITOL HEIGHTS.

TAXABLE PROPERTY. ALL PROPERTY, REAL AND PERSONAL, IN SAID TERRITORY SHALL BE SUBJECT TO ASSESSMENT, LEVY
