(4) North 47°11' 55" West 321.35 feet to an iron pipe, thence (5) South 55°57' 05" West 215.21 feet to a point in the center of the Emmitsburg-Waynesboro Road, thence with said centerline (6) South 47°11' 55" East 299.75 feet, to the place of beginning, be added to the corporate limits of the Town of Emmitsburg, Maryland.

AND, FURTHER RESOLVED that persons and property therein shall be generally subject to the provisions of the Charter of the Town of Emmitsburg, Maryland.
