RESOLUTION OF THE BURGESS AND COMMISSIONERS OF  
MIDDLETOWN

A MUNICIPAL CORPORATION OF THE STATE OF MARYLAND  
TO AMEND THE CHARTER

RESOLUTION of the Burgess and Commissioners of Middletown, adopted pursuant to the authority of Article 11-E of the Constitution of Maryland, and Section 13 of Article 23A of the Annotated Code of Maryland, 1957 (1966 Replacement Volume), title "Corporations - Municipal," to repeal and re-enact, with amendments, Section 20-21, Article II of Chapter 20 of the Frederick County Code, 1959, so as to provide that the age of voters shall be 18 years rather than 21 years, and to repeal and re-enact, with amendments, Section 20-24, Article II, of Chapter 20 of the Frederick County Code, 1959, so as to provide that the Burgess and Commissioners of said municipal corporation, at the time of their election,
