

COUNTY LOCAL LAWS

NORTHERLY ALONG SAID BOUNDARY LINE 320' TO A POINT; THENCE AT RIGHT ANGLES IN A WESTERLY DIRECTION 230' + TO THE WESTERN BOUNDARY OF SAID PARCEL; THENCE SOUTHERLY BINDING ALONG SAID WESTERN BOUNDARY TO THE SHORELINE OF SOUTH RIVER, A DISTANCE OF 300' +; THENCE EASTERLY BINDING ALONG SAID SHORELINE 1000' + TO THE POINT OF BEGINNING.

(17) MAP NO. Q 25 BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(A-29)":

CHANGE THE SUNNY SHORES, INC. PROPERTY FROM R2 - RESIDENTIAL DISTRICT TO OS - OPEN SPACE DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THE PROPERTY OWNED BY SUNNY SHORES, INC. AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 1801, FOLIO 160. SAVING AND EXCEPTING THAT AREA PROPOSED FOR MA1 ACCORDING TO AMENDMENT A-28. A PIECE OF PROPERTY THAT LIES ON THE NORTH SHORE OF SOUTH RIVER AND EAST OF PINE DRIVE AND WEST OF SCNNE DRIVE.

(18) MAPS NOS. Q 23 AND R 23 BE, AND THEY ARE HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAPS AS "(A-30)":

CHANGE THE SYLMAC AND OTHERS PROPERTY FROM RA - AGRICULTURAL RESIDENTIAL DISTRICT TO R2 - RESIDENTIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THAT SUBDIVISION KNOWN AS SYLMAC AND RECORDED IN THE SUBDIVISION RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, PLAT BOOK 31, PAGE 72 AND ALL OF THAT PROPERTY OWNED BY ROBERT B. GARICO AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 1824, FOLIO 365. THE SUBDIVISION LOCATED AT THE SOUTHWEST CORNER OF THE INTERSECTION OF CHESTERFIELD ROAD AND CROWNSVILLE ROAD.

(19) MAPS NOS. Q 26 (REVISED 3/6/72) AND R 26 (REVISED 3/6/72) BE, AND THEY ARE HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAPS AS "(A-31)":

CHANGE THE GLEN ISLE ESTATES PROPERTY FROM R1 - RESIDENTIAL DISTRICT TO R2 - RESIDENTIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THAT SUBDIVISION KNOWN AS GLEN ISLE ESTATES AND RECORDED IN THE SUBDIVISION RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, PLAT BOOK 9, PAGE 31; BOOK 10, PAGE 45; BOOK 17, PAGE 37; BOOK 21, PAGE 37.
