CHANGE THE CARVILLE HOPKINS - MID ATLANTIC TOYOTA PROPERTY FROM C2 - COMMERCIAL OFFICE DISTRICT TO C4 - HIGHWAY COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE NORTHWEST CORNER OF MD. RT. 450 BEING 180' WEST OF MD.
