AND OTHERS PROPERTY FROM R15 - LOW DENSITY MULTI-FAMILY DISTRICT TO R2 - RESIDENTIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THAT AREA RECOMMENDED FOR 19-R15-1 ZONING ON THE RECOMMENDED COMPREHENSIVE ZONING MAP. A LARGE TRACT OF LAND SOUTH OF RT. 50, EAST OF BROAD CREEK AND WEST OF SOUTH RIVER.

CHANGE THE HARRY T. KRAUSE AND RESEARCH LAND CORP. PROPERTY FROM R15 - LOW DENSITY MULTI-FAMILY DISTRICT TO W1A - RESEARCH AND DEVELOPMENT DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE NORTHEASTERNMOST POINT OF THE GINGERVILLE SUBDIVISION; THENCE NORTHEASTERLY 570' + TO A POINT OF INTERSECTION WITH THE SOUTHERN BOUNDARY OF THAT PROPERTY OWNED BY HARRELL SPRWILL, LIBER 1687, FOLIO 535; THENCE SOUTH 49 DEGREES 58 MINUTES EAST FOR A DISTANCE OF 500'; THENCE SOUTH 42 DEGREES 32 MINUTES WEST FOR A DISTANCE OF 890'; THENCE NORTH 20 DEGREES 40 MINUTES WEST TO THE POINT OF BEGINNING.

KRAUSE PROPERTY FROM R15 - LOW DENSITY MULTI-FAMILY DISTRICT TO R2 - RESIDENTIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE SOUTHWESTERLY CORNER OF THE SAMUEL KATCEP PROPERTY, LIBER 1481, FOLIO 523; THEN BINDING ON THE SOUTHERN BOUNDARY OF SAID PROPERTY TO ITS INTERSECTION WITH THE WESTERN SIDE OF MD.
