CHANGE THE ANNAPOLIS BROADCASTING CO. PROPERTY FROM R2 - RESIDENTIAL DISTRICT TO C3 - GENERAL COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT A POINT ON BAY RIDGE ROAD 150' SOUTHEAST OF THE NORTHWESTERMOST BOUNDARY OF THE PROPERTY OWNED BY ANNAPOLIS BROADCASTING CO. AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 386, FOLIO 479; THENCE SOUTHEASTERLY BINDING ALONG SAID ROAD 200 FEET TO A POINT; THENCE SOUTHWESTERLY AT RIGHT ANGLES 150' TO A POINT; THENCE NORTHWESTERLY 150' FROM AND PARALLEL TO BAY RIDGE ROAD FOR A DISTANCE OF 200'; THENCE SOUTHEASTERLY AT RIGHT ANGLES 150' TO THE PLACE OF BEGINNING.

CHANGE THE ANNAPOLIS CATV PROPERTY FROM R2 - RESIDENTIAL DISTRICT TO C3 - GENERAL COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE END OF THE FOURTH LINE OF A DEED CONVEYING A PARCEL OF LAND TO ANNAPOLIS CATV AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 2355, FOLIO 85; THENCE REVERSELY BINDING ALONG SAID LINE SOUTH 22 DEGREES 55 MINUTES 10 SECONDS EAST A DISTANCE OF 200' TO A POINT; THENCE AT RIGHT ANGLES IN A SOUTHWESTERLY DIRECTION 200' TO A POINT; THENCE NORTHWESTERLY AT RIGHT ANGLES AND RUNNING PARALLEL TO AND 200' FROM SAID AFOREMENTIONED LINE OF SAID DEED, 200' TO A POINT; THENCE NORTHEASTERLY AT RIGHT ANGLES 200' TO THE PLACE OF BEGINNING.
