JULY 1, 1972 SHALL PAY THE CONNECTION CHARGES IN EFFECT PRIOR TO SAID DATE, PROVIDED APPLICATION BE MADE THEREFOR WITHIN ONE (1) YEAR OF THE DATE OF RELEASE OF SAID SYSTEM FCR SERVICING. ALL OTHER APPLICATIONS SHALL BE SUBJECT TO THE CHARGES HEREINAFTER SET FORTH.

(3) THE OWNERS OF ANY SUBDIVISION IN VARIOUS STAGES OF PROCESSING BY THE CCUNTY SHALL PAY THE CAPITAL CONNECTION CHARGES HERETOFORE IMPOSED ON THOSE DWELLING UNITS WHERE CONNECTION PERMITS CAN BE ISSUED UNTIL JULY 1, 1973.]]

SECTION 17-610. COMPUTATION OF SPECIAL BENEFIT CHARGES.

IF THE TOTAL OF ANTICIPATED DEBT SERVICE EXPENSE SHALL EXCEED THE TOTAL OF ANTICIPATED REVENUES [[FROM THE CAPITAL CONNECTION CHARGES, FRONT FOOT BENEFIT ASSESSMENTS AND INTEREST INCOME EARNED IN]] OF THE DEBT SERVICE FUND AND ALL OTHER FUNDING SOURCES AVAILABLE IN THE UTILITY FUND, THE DIRECTOR OF PUBLIC WORKS SHALL INCLUDE IN THE ENSUING CURRENT EXPENSE BUDGET SUCH RATE FOR SPECIAL BENEFIT CHARGES AS MAY BE NECESSARY TO ELIMINATE THE DEFICIENCY. THE RATE PER FRONT FOOT SHALL BE ESTABLISHED IN ACCORDANCE WITH THE FOLLOWING FORMULA:

THE AMOUNT SO ALLOCATED TO THE SPECIAL BENEFIT CHARGE SHALL BE DIVIDED BY THE SUM OF THE NUMBER OF FRONT FEET OF WATER AND WASTEWATER LINES IN SERVICE PLUS THE NUMBER TO BE PLACED IN SERVICE DURING THE FIRST SIX (6) MONTHS OF THE FISCAL YEAR.

SECTION 17-611. AUTHORIZATION OF AGREEMENTS.

- (A) (1) THE COUNTY MAY ENTER INTO APPROPRIATE AGREEMENTS WITH DEVELOPERS WHICH, AMONG OTHER THINGS, MAY PROVIDE FOR REASONABLE CREDITS AGAINST ANY SPECIAL WATER AND WASTEWATER EENFIT CHARGES, CAPITAL CONNECTION CHARGES AND OTHER SUCH CHARGES IN CONSIDERATION OF THE CONSTRUCTION BY SUCH DEVELOPERS AT THEIR OWN EXPENSE (OR CONSTRUCTION BY THE COUNTY WITH FUNDS POSTED BY SUCH DEVELOPERS) OF WATER PRODUCING OR DISTRIBUTION FACILITIES, AND WASTEWATER COLLECTION OR TREATMENT FACILITIES, AND THE CONVEYANCE OF SUCH FACILITIES TO THE COUNTY WITHOUT COST.
- (2) IN THE EVENT THAT CONSTRUCTION OF THE FACILITIES IS DONE BY THE DEVELOPER, IT SHALL BE UNDER
