

ANNE ARUNDEL COUNTY

NOTWITHSTANDING THE PROVISIONS OF SECTION 12-226 OF THIS SUBTITLE, NO CHARGE OR FEE FOR CONCESSIONS SHALL BE MADE TO ANY QUALIFIED APPLICANT FOR A LICENSE TO OPERATE A CARNIVAL, CIRCUS, SHOW, AMUSEMENT RIDE OR AMUSEMENT DEVICE ON BEHALF OF ANY VOLUNTEER FIRE COMPANY, WAR VETERANS' ORGANIZATION, OR ANY BONA FIDE PATRIOTIC, EDUCATIONAL, FRATERNAL, RELIGIOUS, CHARITABLE, BENEVOLENT OR CIVIC ORGANIZATION OR CORPORATION, PROVIDED SAID APPLICANT:

(1) HAS BEEN GRANTED A TAX EXEMPT STATUS BY THE UNITED STATES INTERNAL REVENUE SERVICE ON THE BASIS OF A CHARITABLE OR "NON-PROFIT" EXEMPTION; AND

(2) HAS BEEN ORGANIZED OR INCORPORATED FOR NOT LESS THAN ONE (1) YEAR PRIOR TO SAID APPLICATION; AND

(3) HAS A RESIDENT AGENT WHO HAS RESIDED WITHIN THE COUNTY FOR NOT LESS THAN ONE (1) YEAR PRIOR TO SAID APPLICATION; AND

(4) HAS FILED A CERTIFIED COPY OF ITS CHARTER WITH THE CLERK FOR THE CIRCUIT COURT OF ANNE ARUNDEL COUNTY NOT LESS THAN ONE (1) YEAR PRIOR TO SAID APPLICATION.

SECTION 12-226

(A) CLASS D LICENSES SHALL BE ISSUED FOR CARNIVALS. THE FEE (EXCLUDING THOSE QUALIFIED APPLICANTS SET FORTH IN SECTION 12-208 OF THIS SUBTITLE) SHALL BE AS FOLLOWS:

FROM 1 TO 10 CONCESSIONS.....	\$ 100.00 PER WEEK
FROM 11 TO 20 CONCESSIONS.....	200.00 PER WEEK
FROM 21 TO 40 CONCESSIONS.....	300.00 PER WEEK
OVER 40 CONCESSIONS.....	400.00 PER WEEK

(B) THE TERM "CONCESSION" AS USED HEREIN SHALL ONLY INCLUDE RIDES, GAMES, SHOWS AND EVENTS PERMITTED BY LAW, AND THE ISSUANCE OF SAID LICENSE SHALL NOT AUTHORIZE THE OPERATION OF ANY GAMES, DEVICES OR CONTRIVANCES DEEMED TO BE UNLAWFUL BY FEDERAL OR STATE LAW.

SECTION 12-227

(A) EACH APPLICANT REQUESTING THE ISSUANCE OF A CLASS D LICENSE SHALL FILE WITH THE DEPARTMENT OF INSPECTIONS AND PERMITS, A WRITTEN APPLICATION WHICH
