

## ANNE ARUNDEL COUNTY

NATURE OF ANY CRIMINAL CONVICTION OF THOSE PERSONS DESIGNATED IN SUBSECTIONS (A) (1), (2), (5) AND (6) OF THIS SECTION. THE DIRECTOR OF THE DEPARTMENT OF INSPECTIONS AND PERMITS SHALL CONSIDER SAID INFORMATION IN MAKING HIS DETERMINATION AS TO THE ADVISABILITY OF ISSUING SAID LICENSE.

(D) EACH CLASS D LICENSE SHALL SHOW THE NUMBER OF DAYS, AND THE BEGINNING AND ENDING DATES DURING WHICH IT SHALL BE LAWFUL FOR THE LICENSEE TO OPERATE.

## SECTION 12-228

(A) NO CLASS D LICENSE SHALL PERMIT THE OPERATION OF ANY CARNIVAL ON ANY SUNDAY AND THE OPERATION OF ANY SUCH CARNIVAL ON SUNDAYS IS HEREBY PROHIBITED.

(B) NO CARNIVAL SHALL BE OPERATED AFTER 12:00 MIDNIGHT, AND NOT AFTER 2:00 A.M. ON THE LAST NIGHT OF OPERATION.

(C) NO APPLICANT MAY OBTAIN MORE THAN TWO (2) CLASS D LICENSES IN ANY ONE (1) CALENDAR YEAR, OR MAY OPERATE THE ACTIVITIES PERMITTED THEREBY FOR A PERIOD GREATER THAN TWELVE (12) DAYS IN ANY ONE (1) CALENDAR YEAR.

(D) NO PERSON OPERATING A GAME DEVICE, OR CONTRIVANCE AUTHORIZED HEREIN, SHALL HAVE BEEN CONVICTED OF A FELONY.

(E) IF SAID LICENSE IS ISSUED TO A QUALIFIED APPLICANT PURSUANT TO THE PROVISIONS OF SECTION 12-208 OF THIS SUBTITLE, EACH GAMBLING DEVICE OR GAME OF CHANCE SHALL BE OPERATED BY, AND UNDER THE EXCLUSIVE CONTROL OF, A MEMBER OF SAID QUALIFIED LICENSEE WHO HAS RESIDED AND PAID TAXES IN THE STATE OF MARYLAND FOR NOT LESS THAN ONE (1) YEAR IMMEDIATELY PRECEDING THE DATE OF ISSUANCE OF SAID LICENSE.

(F) A COPY OF THE LICENSE AND THE NAME OF THE OPERATOR SHALL BE PROMINENTLY POSTED OR DISPLAYED.

(G) NOT LESS THAN SEVENTY-FIVE PERCENT (75%) OF THE PERSONNEL INVOLVED IN THE ACTUAL OPERATION OF ANY CARNIVAL, BAZAAR, LAWN FETE, OR OTHER FUND-RAISING BENEFIT AUTHORIZED BY VIRTUE OF THE PROVISIONS OF SECTION 12-208 OF THIS SUBTITLE SHALL BE MEMBERS OF THE QUALIFIED LICENSEE.
