(8) MAP NO. P11 BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(A19)":

CHANGE THE AUGUSTA PRALEY AND HOWARD SLIVECKY PROPERTY FROM R1 - RESIDENTIAL DISTRICT TO R5 - RESIDENTIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE NORTHWEST CORNER OF ELVATON ROAD AND THE EASTERNMOST BOUNDARY LINE OF THAT PARCEL OF LAND OWNED BY HOWARD SLIVECKY AND RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 511, FOLIO 279; THENCE NORTHERLY BINDING ALONG SAID BOUNDARY 300'± TO THE NORTHERNMOST BOUNDARY OF SAID PARCEL; THENCE NORTHERLY BINDING ALONG AN EXTENSION OF SAID EASTERN BOUNDARY OF SAID PARCEL 450'± TO THE SOUTHERN BOUNDARY OF THAT AREA RECOMMENDED FOR 6-R5-12; THENCE WESTERLY 675'± TO THE EASTERNMOST BOUNDARY OF THAT AREA RECOMMENDED FOR 6-R5-12; THENCE SOUTHERLY 500'± BINDING ALONG SAID EASTERN BOUNDARY OF SAID ZONE TO THE NORTHERN SIDE OF ELVATON ROAD; THENCE EASTERLY 630'± BINDING ALONG SAID SIDE OF SAID ROAD TO THE PLACE OF BEGINNING.

(9) MAP NO. U7 BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(A3)":

CHANGE THE ALBERT LANDAY PROPERTY FROM R5 - RESIDENTIAL DISTRICT TO C3 - GENERAL COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE NORTHEAST CORNER OF THE INTERSECTION OF THE EAST SIDE OF RT. 173 AND THE NORTHERN BOUNDARY LINE OF RECOMMENDED ZONE 7-C3-1; THENCE BINDING THE EAST SIDE OF SAID ROAD 200'± TO THE EAST SIDE OF A 20' RIGHT-OF-WAY; THENCE NORTH 65 DEGREES 44 MINUTES 54 SECONDS EAST 300'±; THENCE SOUTH 300' FROM THE EAST SIDE OF AND PARALLEL TO RT. 173 FOR A DISTANCE OF 200'± TO THE NORTHEAST CORNER OF SAID RECOMMENDED ZONE 7-C3-1; THENCE SOUTHWESTERLY AND BINDING THE NORTHERN BOUNDARY LINE OF SAID ZONE 300'± TO THE PLACE OF BEGINNING.
