

## COUNTY LOCAL LAWS

(30) MAP NO. R10 BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(D17)":

CHANGE THE THEODORE WOLF PROPERTY FROM R1 - RESIDENTIAL DISTRICT TO C4 - HIGHWAY COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THAT PROPERTY OWNED BY THEODORE WOLF AS RECORDED AMONG THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, LIBER 326, FOLIO 197. A PIECE OF PROPERTY SOUTH OF MOUNTAIN ROAD AND WEST OF OLD ANNAPOLIS ROAD AND EAST OF JUMPERS HOLE ROAD RELOCATED.

(32) MAP NO. V11 BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(D27)":

CHANGE THE SOUTHWESTERN LIFE INSURANCE COMPANY PROPERTY FROM R2 - RESIDENTIAL DISTRICT C4 - HIGHWAY COMMERCIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEGINNING FOR THE SAME AT THE NORTHEAST CORNER OF THE INTERSECTION OF MOUNTAIN ROAD AND PARK AVENUE; THENCE NORTHERLY BINDING ALONG THE EASTERN SIDE OF PARK AVENUE FOR A DISTANCE OF 150 FEET; THENCE EASTERLY PARALLEL TO AND 150 FEET FROM THE NORTH SIDE OF MOUNTAIN ROAD FOR A DISTANCE OF 200 FEET; THENCE SOUTHERLY PARALLEL TO AND 200 FEET FROM THE EAST SIDE OF PARK AVENUE FOR A DISTANCE OF 150'± TO THE NORTH SIDE OF MOUNTAIN ROAD; THENCE WESTERLY BINDING ALONG SAID SIDE OF SAID ROAD 200'± TO THE PLACE OF BEGINNING.

(33) MAP NO. AA10 BE, AND IT IS HEREBY AMENDED AS FOLLOWS, SAID AMENDMENT BEING DESIGNATED ON SAID MAP AS "(D31)":

CHANGE THE JOHN ROBINSON ESTATE PROPERTY FROM R22 - MEDIUM DENSITY MULTI-FAMILY DISTRICT TO R15 - LOW DENSITY MULTI-FAMILY DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF THAT AREA ON RECOMMENDED ZONING MAP FOR THE NORTHERN THIRD ASSESSMENT DISTRICT AS 8-R22-1. A PIECE OF PROPERTY ON BODKIN NECK NEAR THE POINT.
