PARKER AS RECORDED IN THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, IN LIBER 670, FOLIO 260. SAVING AND EXCEPTING THAT PORTION OF THE PROPERTY ON THE SOUTHWEST INTERSECTION OF RT. 100 AND QUARTERFIELD ROAD.

CHANGE THE PHELPS AND SANDBURY PROPERTY FROM R5 - RESIDENTIAL DISTRICT AS PROPOSED AND AS AMENDED TO C2 - COMMERCIAL OFFICE DISTRICT BY AMENDMENT NO. 91 TO R5 - RESIDENTIAL DISTRICT, SAID PROPERTY BEING DESCRIBED AS FOLLOWS: BEING ALL OF LOTS 1-6, BLOCK B, OF A SUBDIVISION OF GERARD PLAZA AND BEGINNING FOR THE SAME AT A POINT ON THE NORTHERLY SIDE OF PHELPS AVENUE AT THE SOUTHEASTERLY CORNER OF LOT NO. 7, AS SHOWN ON THE PLAT ENTITLED "RE-SUBDIVISION OF PART OF GERARD PLAZA", RECORDED AMONG THE LAND RECORDS OF ANNE ARUNDEL COUNTY, MARYLAND, IN PLAT BOOK 31, PAGE 49, AS PLAT NO. 1624, THENCE BINDING ON THE NORTHERLY SIDE OF PHELPS AVENUE AND REFERRING THE COURSES OF THIS DESCRIPTION TO THE ANNE ARUNDEL COUNTY SANITARY COMMISSION GRID MERIDIAN (1) BY A CURVE TO THE RIGHT HAVING A RADIUS OF 1200.00' AND A LENGTH OF ARC OF 39.27' TO A POINT OF COMPOUND CURVATURE, THENCE BINDING ON A CURVE TO THE RIGHT; (2) HAVING A RADIUS OF 190.00', A LENGTH OF ARC
