## HOWARD COUNTY

SUBMITTED TO THE COUNTY EXECUTIVE BY THE PLANNING BOARD, THE DEPARTMENT OF RECREATION AND PARKS SHALL FILE WITH THE DEPARTMENT OF ASSESSMENTS A COMPLETE LIST OF ALL PROPERTIES INTENDED TO BE PURCHASED BY THE COUNTY UNDER THE DEPARTMENT OF RECREATION AND PARKS PROGRAM AS SET OUT IN THE CAPITAL BUDGET OF THE DEPARTMENT OF RECREATION AND PARKS.

- (B) THE DEPARTMENT OF ASSESSMENTS SHALL NOTIFY THE OWNERS OF ASSESSMENT RECORD OF ALL THE PARCELS OF PROPERTY INCLUDED IN THE CAPITAL BUDGET OF THE DEPARTMENT OF RECREATION AND PARKS AT THE EXPENSE OF THE DEPARTMENT OF RECREATION AND PARKS. THE NOTICE TO PROPERTY CWNERS SHALL BE MAILED TO THE ADDRESS SHOWN FOR THE PROPERTY OWNERS IN THE ASSESSMENT RECORDS, BY CERTIFIED MAIL NO RETURN RECEIPT NECESSARY.
- (C) (1) THE NOTICE SHALL INFORM THE OWNER OF THAT PART OF HIS PROPERTY PROPOSED TO BE TAKEN BY THE COUNTY UNDER THE RECREATION AND PARKS PROGRAM AS DESCRIBED IN THE CAPITAL BUDGET.
- (C) (2) THE NOTICE SHALL INFORM THE CWNER OF THE DATE, TIME AND PLACE OF THE PUBLIC HEARING BY THE COUNTY COUNCIL ON THE CAPITAL BUDGET OF THE DEPARTMENT OF RECREATION AND PARKS.
- (D) THE SECRETARY OF THE COUNTY COUNCIL SHALL SET THE DATE OF THE PUBLIC HEARING AT THE TIME THE COUNTY BUDGET IS SUBMITTED TO THE COUNTY EXECUTIVE BY THE PLANNING BOARD.
- (E) NOT LESS THAN FIFTEEN (15) DAYS PRIOR TO THE TIME THE COUNTY BUDGET IS SUBMITTED TO THE COUNTY COUNCIL BY THE COUNTY EXECUTIVE, THE DIRECTOR OF RECREATION AND PARKS SHALL HAVE PRINTED IN TWO (2) NEWSPAPERS PUBLISHED IN THE COUNTY, A MAP SHOWING THE COUNTY'S ENTIRE RECREATION AND PARKS PROGRAM, AND IDENTIFYING THOSE AREAS INCLUDED IN THE CAPITAL BUDGET OF THE DEPARTMENT OF RECREATION AND PARKS.]

## NOTICE OF PROPOSED ANNUAL RECREATION AND PARKS CAPITAL PROGRAM

(A) PRIOR TO THE SUBMISSION OF THE PROPOSED CAPITAL PROGRAM FOR RECREATION AND PARKS TO THE PLANNING BOARD, THE RECREATION AND PARKS BOARD SHALL HOLD A PUBLIC HEARING ON THE PROPOSED PROGRAM FOR THE NEXT SUCCEEDING FISCAL YEAR. SUCH HEARING SHALL BE HELD NOT LATER THAN 30 DAYS PRIOR TO THE DATE OF
