- (14) PERFORM SUCH OTHER DUTIES AND INVESTIGATIONS AS MAY FROM TIME TO TIME BE REQUIRED BY THE COUNTY EXECUTIVE.
- (15) PREPARE AND SUBMIT A BUDGET TO INCLUDE THE RECOMMENDED APPROPRIATIONS FOR DRUG PROGRAMS AND FOR ITS OWN OPERATION.

SECTION 8A-6. REGISTRATION AND LICENSING REQUIRED FOR CERTAIN DRUG-RELATED ACTIVITIES.

- (A) REGISTRATION REQUIRED. EVERY PERSON WHO OPERATES OR CONDUCTS A DRUG-RELATED PROGRAM WITHIN THE COUNTY SHALL REGISTER WITH THE OFFICE OF DRUG CONTROL ON A FORM PRESCRIBED BY SUCH OFFICE.
- (B) PROGRAM LICENSE. UNLESS LICENSED BY THE STATE FOR SUCH PURPOSES, NO PERSON SHALL ESTABLISH, CONDUCT, MAINTAIN OR OPERATE A DRUG-RELATED PROGRAM IN THIS COUNTY WITHOUT A LICENSE AS HEREIN PROVIDED, WHEN SUCH DRUG-RELATED PROGRAM INCLUDES ONE OR MORE OF THE FOLLOWING:
- (1) THE SOLICITATION OF FUNDS, PRIVATELY OR PUBLICLY, FOR THE OPERATION OF SUCH PROGRAM.
- (2) WHEN SUCH PROGRAM INCLUDES THE REPRESENTATION THAT IT PROVIDES SERVICES TO DRUG DEPENDENT PERSONS, OR TO THEIR RELATIVES, FOR COMPENSATION.
- (3) WHEN SUCH PROGRAM INCLUDES THE ESTABLISHMENT OR OPERATION, OR CONTEMPLATES THE ESTABLISHMENT, OF A DRUG-RELATED FACILITY.
- (C) DRUG-RELATED FACILITY LICENSE. NO PERSON SHALL ESTABLISH, CONDUCT, MAINTAIN OR OPERATE A DRUG-RELATED FACILITY WITHIN THE COUNTY, WHETHER PUBLIC OR PRIVATE IN CHARACTER, WHETHER FOR PROFIT OR NON-PROFIT, WITHOUT OBTAINING A LICENSE AS REQUIRED HEREIN FOR SUCH FACILITY. ANY LICENSE FOR A DRUG-RELATED FACILITY SHALL ALSO HAVE A DRUG-RELATED PROGRAM LICENSE.
- (D) APPLICATION. ANY PERSON DESIRING A LICENSE FOR A DRUG-RELATED PROGRAM OR A DRUG-RELATED FACILITY, OR BOTH SUCH LICENSES SHALL MAKE APPLICATION TO THE DIRECTOR OF THE OFFICE OF DRUG CONTROL. THE APPLICATION SHALL BE IN THE FORM PRESCRIBED BY THE DIRECTOR WITH THE ADVICE OF THE COMMISSION. THE
