THE WORDS "DEPARTMENT OF ENVIRONMENTAL PROTECTION" ARE HEREBY SUBSTITUTED FOR "DEPARTMENT OF HEALTH," "DIVISION OF SANITATION," AND "DIVISION OF ENVIRONMENTAL HEALTH" AND "COUNTY HEALTH OFFICER" SHALL HEREAFTER MEAN "DIRECTOR" OF THE DEPARTMENT OF ENVIRONMENTAL PROTECTION AND HIS AUTHORIZED AGENTS IN THE FOLLOWING CHAPTERS, ARTICLES, SECTIONS, AND SUBSECTIONS OF THIS CODE AND IN THE RESOLUTIONS BELOW; ALL AS MAY HAVE BEEN AMENDED:
