company, association or corporation operating, or attempting to operate any such benefit performance in violation hereof, shall, upon conviction of such violation, be subject to a fine not exceeding one thousand dollars or imprisonment in jail for a period of not more than one year, or both such fine and imprisonment, in the discretion of the court.]

SEC. 50-4 (B). PERMITTED ACTIVITIES.

THE AFOREMENTIONED ELIGIBLE GROUP OR ORGANIZATION MAY CONDUCT AND OPERATE ANY BENEFIT PERFORMANCE, SUCH AS AN OUTDOOR OR INDOOR CARNIVAL, RAFFLE OR ANY OTHER ACTIVITY TO WHICH THE PUBLIC IS INVITED OR ADMITTED, WITH OR WITHOUT CHARGE FOR SUCH ADMISSION, THE INTENT OF WHICH IS TO RAISE PROCEEDS FOR THE PURPOSE SET FORTH IN SECTION 50-4(C). THE TERM "RAFFLE" AS USED HEREIN SHALL MEAN ONE OR MORE DRAWINGS FROM A SINGLE SERIES OF CHANCES SOLD BY MEANS OF CHANCE BOOKS.

SEC. 50-4 (C). PROCEEDS.

THE PROCEEDS OF SUCH BENEFIT PERFORMANCE SHALL INURE TO SUCH GROUP OR ORGANIZATION FOR THE PROMOTION OF AND TO BE USED FOR ANY CHARITABLE, BENEVOLENT, PATRIOTIC, EDUCATIONAL, RELIGIOUS OR CIVIC OBJECT OR OBJECTS AND NOT FOR THE PRIVATE GAIN OF ANY MEMBER OF SUCH GROUP OR ORGANIZATION.

SEC. 50-4 (D). PERMITS REQUIRED.

BEFORE OPERATING ANY SUCH BENEFIT PERFORMANCE, AT WHICH GAMES DESIGNATED IN SECTION 50-4 (H) ARE TO BE ENGAGED IN TO RAISE FUNDS, ANY SUCH ELIGIBLE GROUP OR ORGANIZATION SHALL FIRST OBTAIN FROM THE DEPARTMENT OF LICENSES AND PERMITS FOR PRINCE GEORGE'S COUNTY A WRITTEN PERMIT THEREFOR. APPLICATION THEREFOR SHALL BE MADE ON FORMS TO BE PROVIDED BY SAID DEPARTMENT AND SHALL BE MADE AT LEAST 10 DAYS PRIOR TO INITIAL OPERATION. THE APPLICATION SHALL BE ACCOMPANIED BY ANY CONTRACT WITH A PROFESSIONAL CARNIVAL OPERATOR OR PROMOTOR; SUCH CONTRACT SHALL NOT CONTAIN ANY COVENANT PROVIDING FOR PAYMENT CONTINGENT UPON THE RECEIPT OR INTAKE OF ANY PERMITTED GAME OF SKILL, MECHANICAL DEVICE, OR BINGO AS HEREAFTER DESCRIBED. THE APPLICATION SHALL SET FORTH THE FOLLOWING WITH RESPECT TO SAID GROUP OR ORGANIZATION:

1. THE NAME OF SAID GROUP OR ORGANIZATION AND A FULL LIST OF THE NAMES AND ADDRESSES OF ITS OFFICERS
