THE ANNUAL SEVEN (7) DAY LICENSE FEE, WHICH SHALL BE AVAILABLE ONLY IN THE TENTH ELECTION DISTRICT, SHALL BE TWO HUNDRED FIFTY DOLLARS (\$250.00). THE HOURS FOR SALE SHALL BE ~~[[THE SAME AS FOR CLASS B LICENSES]]~~ AS PROVIDED IN SECTION 106(C) OF THIS ARTICLE.
