

(K) IN WORCESTER COUNTY THE ANNUAL LICENSE FEE FOR SUCH A LICENSE SHALL BE ONE HUNDRED TWENTY-FIVE DOLLARS (\$125.00). THE HOURS FOR SALE SHALL BE [FROM 9:00 A.M. UNTIL 2:00 A.M. THE FOLLOWING MORNING, EXCEPT THAT THERE SHALL BE NO SALES ON SUNDAY BETWEEN 2:00 A.M. AND 9:00 A.M. MONDAY MORNING.] AS PROVIDED IN SECTION 106 (C) OF THIS ARTICLE.

[(k)] (L) This section shall not apply to Baltimore City, nor to Anne Arundel, Baltimore, Charles, Garrett, Harford, Kent, St. Mary's and Somerset counties, in all of which jurisdictions such licenses shall not be issued.

(N) IN WORCESTER COUNTY THERE SHALL BE SUCH A LICENSE AND THE ANNUAL LICENSE FEE FOR A

(1) SIX DAY LICENSE SHALL BE TWO HUNDRED DOLLARS (\$200.00), AND

(2) SEVEN DAY LICENSE SHALL BE TWO HUNDRED TWENTY-FIVE DOLLARS (\$225.00). THE SEVEN DAY LICENSE OF THIS SECTION SHALL BE PERMITTED ONLY IN THE TENTH ELECTION DISTRICT OF WORCESTER COUNTY. THE HOURS FOR SALE FOR THESE LICENSES SHALL BE AS PROVIDED IN SECTION 106(C) OF THIS ARTICLE.

[(n)] (O) This section shall not apply to Baltimore City, nor to Anne Arundel, Baltimore, Frederick, Harford, Somerset, and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

(K) IN WORCESTER COUNTY THE ANNUAL SIX (6) DAY LICENSE FEE SHALL BE ONE HUNDRED [(DOLLARS (\$100))] FIFTY DOLLARS (\$150.00) AND THE ANNUAL SEVEN (7) DAY LICENSE FEE SHALL BE ONE HUNDRED [TWENTY-FIVE DOLLARS (\$125)] SEVENTY-FIVE DOLLARS (\$175.00). THE HOURS FOR SALE SHALL BE AS PROVIDED IN SECTION 106 (C) OF THIS ARTICLE.

[(k)] (L) This section shall not apply to the City of Annapolis nor to Calvert, Charles, Dorchester, Garrett, Howard, Kent, Queen Anne's, St Mary's, and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

(L) IN WORCESTER COUNTY THE ANNUAL SIX (6) DAY LICENSE FEE SHALL BE TWO HUNDRED DOLLARS (\$200.00). THE ANNUAL SEVEN (7) DAY LICENSE FEE SHALL BE TWO HUNDRED FIFTY DOLLARS (\$250.00), WHICH SHALL BE AVAILABLE ONLY IN THE TENTH ELECTION DISTRICT. THE HOURS OF SALE SHALL BE [THE SAME AS FOR CLASS B LICENSES] AS PROVIDED IN SECTION 106 (C) OF THIS ARTICLE.

[(l)] (M) This section shall not apply to Allegany, Calvert, Caroline, Charles, Dorchester, Garrett, Howard, Kent, Queen Anne's, St. Mary's, Somerset and Talbot counties, in all of which jurisdictions such licenses shall not be issued.
