- (I) IN WORCESTER COUNTY THE ANNUAL LICENSE FEE FOR SUCH A LICENSE SHALL BE ONE HUNDRED FIFTY DOLLARS (\$150.00). THE HOURS FOR SALE SHALL BE [IFROM 9:00 A.M. UNTIL 2:00 A.M. THE FOLLOWING MORNING, EXCEPT THAT THERE SHALL BE NO SALES ON SUNDAY BETWEEN 2:00 A.M. AND 9:00 A.M. THE FOLLOWING MONDAY MORNING. II AS PROVIDED IN SECTION 106(C) OF THIS ARTICLE.
- II(i) II (J) This section shall not apply to Calvert, Caroline, Charles, Dorchester, Garrett, Kent, Queen Anne's, St. Mary's, Somerset and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

- (J) IN WORCESTER COUNTY THERE SHALL BE SUCH A LICENSE AND THE ANNUAL LICENSE FEE FOR A
- (1) SIX DAY LICENSE SHALL BE TWO HUNDRED TWENTY-FIVE DOLLARS (\$225.00), AND
- (2) SEVEN DAY LICENSE SHALL BE TWO HUNDRED FIFTY DOLLARS (\$250.00). THIS SEVEN DAY LICENSE SHALL BE PERMITTED ONLY IN THE TENTH ELECTION DISTRICT OF WORCESTER COUNTY.
- THE HOURS FOR SALE SHALL BE AS PROVIDED IN SECTION 106(C) OF THIS ARTICLE.
- II(j)11 (K) This section shall not apply to the City of Annapolis nor to Calvert, Caroline, Charles, Dorchester, Frederick, Garrett, Harford, Howard, Kent, Queen Anne's, St. Mary's, Somerset, and Talbot counties, in all of which jurisdictions such licenses shall not be issued.

(m) In Worcester County six-day licenses may be issued to bona fide hotels having twenty (20) or more rooms, regularly serving meals, or restaurants having a table seating capacity of seventy (70) or more persons, upon payment of an annual fee of Ilseven hundred and fifty dollars (\$750.00)11 ONE THOUSAND DOLLARS (\$1,000.00); in case the premises to be licensed are located within any incorporated town, the application requires approval by the mayor and city council of the town, in addition to approval by the licensing authority; this license shall entitle the licensee to serve beer, wine and liquor as provided in this article on six days of the week, excluding Sunday. A seven-day license may be issued upon payment of an annual fee of I [one thousand dollars (\$1,000.00)1] ONE THOUSAND TWO HUNDRED FIFTY DOLLARS (\$1,250.00), subject to the approval of the mayor and city council of any incorporated town as provided above, in addition to approval by the licensing authority, which license shall authorize sales as provided by this article on seven days of the week.

The hours of sale under these licenses shall be as provided by the applicable provisions of §106(C) of this article.

For the purpose of qualifying for a seven-day license in addition to the definition of a hotel or a restaurant elsewhere in this section, a hotel is an establishment for the accommodation of the public, providing services ordinarily found in hotels, is equipped with no fewer than twenty rooms, a lobby with a
