

8-1307. ACQUISITION, IMPROVEMENT, AND DEVELOPMENT OF LAND OR OTHER PROPERTY WITHIN AREA.

FOR THE PURPOSE OF CARRYING OUT ANY RECOMMENDATION OF THE WATERSHED PLAN OR ANY PART OF IT, EACH COUNTY, THROUGH ITS APPROPRIATE COUNTY GOVERNING BODY OR DULY DESIGNATED AGENCY, IN COOPERATION WITH THE DEPARTMENT, MAY ACQUIRE LAND OR OTHER PROPERTY, BY MEANS OF DONATION, PURCHASE, OR CONDEMNATION, EITHER IN FEE OR BY EASEMENT, LOCATED WITHIN THE AREA OF THE COUNTY FOR THE PUBLIC PURPOSES DELINEATED IN THE PLAN. THE APPROPRIATE COUNTY GOVERNING BODY OR ITS DULY DESIGNATED AGENCY, MAY IMPROVE AND DEVELOP THE ACQUIRED LAND OR OTHER PROPERTY FOR THE PURPOSES OF THE PLAN. IT CONTROLS MAINTENANCE AND OPERATION OF THE LAND OR OTHER PROPERTY.

8-1308. FINANCING.

TO FINANCE OR ASSIST IN FINANCING ACQUISITION OF LAND OR OTHER PROPERTY FOR THE PURPOSES SHOWN ON THE WATERSHED PLAN, OR FOR IMPROVEMENT OR DEVELOPMENT OF THE WATERSHED PLAN, THE APPROPRIATE COUNTY GOVERNING BODY, OR ITS DULY DESIGNATED AGENCY, MAY RECEIVE AND EXPEND ANY CONTRIBUTION, DONATION, OR APPROPRIATION WHICH THE FEDERAL GOVERNMENT, OR ANY PERSON MAKES.

REVISOR'S NOTE: This section presently appears as Article 66C, section 411E of the Code. The word "person" is used in lieu of the enumeration of types of donors because under section 8-101(h) "person" includes these types of donors. The only other changes made are in style and nomenclature.

8-1309. ACQUIRING LANDS OUTSIDE AREA OF PLAN.

THE APPROPRIATE COUNTY GOVERNING BODY, OR ITS DULY DESIGNATED AGENCY MAY ACQUIRE LANDS FOR THE PURPOSES STATED IN THIS SUBTITLE OUTSIDE OF THE AREA OF THE WATERSHED PLAN, IF IT FINDS THAT ACQUISITION IS NECESSARY TO PRESERVE ANY PORTION OF THE WATERSHED PLAN IN ITS COUNTY. THE APPROPRIATE COUNTY GOVERNING BODY, OR ITS DULY DESIGNATED AGENCY MAY EXPEND ANY AUTHORIZED FUNDS UNDER THE PROVISIONS OF THIS SUBTITLE
