

(E) ISSUANCE; FEE. - THE DEPARTMENT MAY ISSUE A SPECIAL LICENSE TO HUNT ON ANY REGULATED SHOOTING GROUND ONLY FOR WILD TURKEY, PHEASANT, BOBWHITE QUAIL, CHUKAR[[,]] PARTRIDGE, AND MALLARD DUCKS. THE DEPARTMENT SHALL ISSUE THE SPECIAL LICENSE UPON PAYMENT OF A \$3.50 LICENSE FEE.

(C) CONTENTS OF LICENSE. - THE LICENSE SHALL BEAR THE SIGNATURE OF THE SECRETARY AND SHALL BE COUNTERSIGNED BY THE ISSUING AGENT WHO AT THE SAME TIME SHALL FILL OUT A STUB ATTACHED TO THE LICENSE BLANK, THE NAME AND ADDRESS OF THE LICENSEE. HE THEN SHALL DETACH THE STUB AND MAIL IT TO THE SECRETARY THE FIRST DAY OF EACH MONTH. THE AGENT SHALL RETAIN 50 CENTS AS COMPENSATION FOR ISSUING EACH LICENSE. THE AGENT SHALL DELIVER THE PROPERLY EXECUTED LICENSE TO THE APPLICANT IN PERSON OR BY MAIL WITHOUT FURTHER COST. THE LICENSEE SHALL INSERT HIS NAME IN INK ON THE LICENSE AT THE TIME OF PURCHASE.

(D) DURATION OF LICENSE. - THE LICENSE SHALL EXPIRE ON JUNE 30 AFTER THE DATE OF ISSUANCE.

(E) LICENSE NON-TRANSFERABLE. - THE LICENSE IS NOT TRANSFERABLE AND IF USED OR PRESENTED BY ANY PERSON OTHER THAN THE PERSON TO WHOM IT WAS ISSUED, THE LICENSE SHALL BE CONFISCATED BY THE SECRETARY, ANY NATURAL RESOURCES POLICE OFFICER, OR ANY LAW ENFORCEMENT OFFICER.

10-910. REVOCATION AND CONFISCATION OF ANY LICENSE.

IN ADDITION TO ANY PENALTY PROVIDED BY THIS TITLE, ANY PERSON WHO IS CONVICTED OF SELLING OR OFFERING FOR SALE ANY GAME BIRD OR MAMMAL IN VIOLATION OF THE PROVISIONS OF THIS SUBTITLE SHALL HAVE HIS LICENSE REVOKED AND SHALL BE FINED \$5 FOR EACH BIRD OR MAMMAL SOLD OR OFFERED FOR SALE.
