

SEC. 7-413. PAYMENT FOR HOGSHEAD.

IF LEAF TOBACCO IS SOLD PACKED IN A HOGSHEAD OR CASK AND NO PRICE IS SPECIFICALLY AGREED UPON BETWEEN THE SELLER AND BUYER, THE BUYER SHALL BE DEEMED TO HAVE AGREED TO PAY \$6 OR THE PREVAILING PRICE FOR A HOGSHEAD OR CASK IF IT EXCEEDS \$6. IN THE ABSENCE OF AN EXPRESS AGREEMENT TO THE CONTRARY, THE SELLER MAY DEMAND THAT THIS SUM BE ADDED TO THE PURCHASE PRICE OF THE TOBACCO.

SEC. 7-414. MAXIMUM SALES PER HOUR.

THE MAXIMUM SALES OF BASKETS OF TOBACCO ON THE FLOOR OF ANY LOOSE LEAF AUCTION WAREHOUSE MAY NOT EXCEED 360 BASKETS DURING ANY ONE HOUR.

SEC. 7-415. SALE OF NESTED TOBACCO PROHIBITED; DUTY TO REPORT TO AUTHORITY.

(A) "NESTED" TOBACCO - DEFINED.

FOR THE PURPOSE OF THIS SECTION, "NESTED" TOBACCO IS ANY LOT OF TOBACCO WHICH IS LOADED, PACKED, OR ARRANGED SO AS TO CONCEAL ANY FOREIGN MATTER OR TOBACCO OF INFERIOR GRADE, QUALITY, OR CONDITION, INCLUDING ANY LOT OF TOBACCO WHICH CONTAINS DAMAGED, TANGLED, OR OTHER INFERIOR TOBACCO WHICH CANNOT BE READILY DETECTED UPON INSPECTION BY VIRTUE OF THE MANNER IN WHICH IT IS PACKED OR ARRANGED.

(B) SELLING OR OFFERING FOR SALE NESTED TOBACCO PROHIBITED.

AN OWNER OF TOBACCO MAY NOT SELL OR OFFER FOR SALE ANY TOBACCO WHICH THE OWNER INTENTIONALLY HAS "NESTED" OR CAUSED TO BE "NESTED".

(C) DUTY OF COMMISSION SELLING AGENCY TO REPORT TO AUTHORITY.

ANY COMMISSION SELLING AGENCY WHICH DISCOVERS OR LEARNS OF ANY NESTED TOBACCO IN ANY LOTS CONSIGNED TO
