HIGHLY ADVANTAGEOUS TO THE STATE'S AGRICULTURAL ECONOMY THAT FARMERS, PRODUCERS, AND GROWERS COMMERCIALLY PRODUCING AGRICULTURAL COMMODITIES PERMITTED BY REFERENDUM TO BE HELD AMONG RESPECTIVE GROUPS AND, SUBJECT TO THE PROVISIONS OF THIS ARTICLE, TO LEVY UPON THEMSELVES AN ASSESSMENT ON THE RESPECTIVE COMMODITIES OR UPON THE ACREAGE USED IN THEIR PRODUCTION AND PROVIDE FOR THE COLLECTION OF THE ASSESSMENT. THE ASSESSMENTS ARE FOR THE FINANCING, OR CONTRIBUTE TOWARDS THE FINANCING, OF A PROGRAM OF ADVERTISING AND OTHER METHODS DESIGNED TO INCREASE CONSUMPTION AND DOMESTIC AND FOREIGN MARKETS FOR ANY AGRICUITURAL COMMODITY. THE ASSESSMENTS ALSO MAY BE USED FOR THE FINANCING, OR TO CONTRIBUTE TOWARDS THE FINANCING, OF A PROGRAM OF PRODUCTION, USE, AND OF ANY AGRICULTURAL COMMODITY.

SEC. 10-103. PROMOTIONAL ACTIVITIES NOT DEEMED ILIEGAL OR IN RESTRAINT OF TRADE.

NO ASSOCIATION, MEETING, OR ACTIVITY UNDERTAKEN IN PURSUANCE OF THE PROVISIONS OF THIS ARTICLE AND INTENDED TO BENEFIT ALL OF THE PRODUCERS, HANDLERS, AND PROCESSORS OF A PARTICULAR AGRICULTURAL COMMODITY SHALL BE DEEMED ILLEGAL OR IN RESTRAINT OF TRADE.
