IT PURSUANT TO THE PROVISIONS OF ARTICLE 78B OF THIS CODE FOR THE PAYMENT OF PREMIUM AWARDS; PROMOTIONAL, EDUCATIONAL ACTIVITIES, OR OTHER ACTIVITIES, EITHER IN CONNECTION WITH A BONA FIDE AGRICULTURAL FAIR, EXHIBIT, OR ACTIVITY, AS THE BOARD DETERMINES, AND FOR ONE STATE FAIR EACH YEAR, AS DESIGNATED BY THE BOARD.

(B) ADOPT FULES AND REGULATIONS FOR FAIRS AND EXHIBITS.

THE BOARD, SUBJECT TO APPROVAL OF THE SECRETARY SHALL ADOPT RULES AND REGULATIONS TO GOVERN THE CONDUCT, QUALIFICATIONS, AND REQUIREMENTS OF AGRICULTURAL FAIRS, EXHIBITS, OR ACTIVITIES TO WHICH ALLOCATIONS OR DISTRIBUTIONS ARE MADE.

(C) FAIRS AND EXHIBITS TO MEET QUALIFICATIONS OF BOARD RULES AND REGULATIONS.

NO AGRICULTURAL FAIR, EXHIBIT, OR ACTIVITY MAY RECEIVE ANY FINANCIAL ASSISTANCE FROM THE BOARD, UNLESS IT HAS MET ALL QUALIFICATIONS AND REQUIREMENTS AS SET FORTH IN THE RULES AND REGULATIONS. THE DECISION OF THE BOARD, AFTER APPROVAL OF THE SECRETARY, SHALL BE FINAL WITH RESPECT TO EVERY QUESTION RELATING TO WHETHER ANY AGRICULTURAL FAIR, EXHIBIT, OR ACTIVITY SHALL BE ENTITLED TO FINANCIAL ASSISTANCE UNDER THE PROVISIONS OF THIS SECTION.
