DEVICES: CORRECT WEIGHT AND MEASURE.

- (A) SECRETARY MAY ADOPT CERTAIN RULES AND REGULATIONS.
- TO ENFORCE THIS TITLE, THE SECRETARY MAY ADOPT RULES AND REGULATIONS RELATING TO:
- (1) STANDARDS OF NET WEIGHT, MEASURE, OR COUNT, REASONABLE STANDARDS OF FILL, AND LABELING REQUIREMENTS, FOR ANY COMMODITY IN PACKAGE FORM;
- (2) EXEMPTIONS FROM THE SEALING OR MARKING REQUIREMENTS OF §11-212 WITH RESPECT TO WEIGHTS AND MEASURES WHOSE CHARACTER OR SIZE MAKES SEALING OR MARKING INAPPROPRIATE, NOT FEASIBLE, OR DAMAGING TO THE WEIGHT AND MEASURE:
- (3) THE PROCEDURES TO BE FOLLOWED BY LOCAL INSPECTORS IN THE DISCHARGE OF THEIR OFFICIAL DUTIES;
- (4) REGISTRATION OF SERVICEMEN AND SERVICE AGENCIES ENGAGED IN THE MAINTENANCE AND REPAIR OF WEIGHING AND MEASURING DEVICES;
- (5) THE TYPES OF COMMODITIES AND OBJECTS TO BE WEIGHED BY LICENSED WEIGHMASTERS;
- (6) THE TYPES OF WEIGHING DEVICES REQUIRING OPERATION BY A LICENSED WEIGHMASTER, THE LICENSING OF WEIGHMASTERS AND APPLICANTS' LICENSING FEES, THE MAINTENANCE OF WEIGHT RECORDS AND INSPECTION OF WEIGHT RECORDS BY THE SECRETARY, LOCAL INSPECTOR, OR DEPUTY LOCAL INSPECTOR.
- (B) RULES AND REGULATIONS GOVERNING SPECIFICATIONS AND TCLERANCES.

THE SECRETARY SHALL ADOPT RULES AND REGULATIONS, SPECIFICATIONS, TOLERANCES, AND OTHER TECHNICAL REQUIREMENTS FOR WEIGHTS AND MEASURES OF THE CHARACTER OF THOSE SPECIFIED IN §11-209, DESIGNED TO ELIMINATE FROM USE, WITHOUT PREJUDICE TO ANY WEIGHT AND MEASURE THAT CONFORMS AS CLOSELY AS FEASIBLE TO THE OFFICIAL STANDARDS, THOSE THAT:

(1) ARE NOT ACCURATE.

(2) ARE CONSTRUCTED SO THAT THEY ARE NOT REASONABLY PERMANENT IN THEIR ADJUSTMENT OR DO NOT REPEAT THEIR INDICATIONS CORRECTLY, OR
