

(B) DISTRIBUTION OF APPEARANCE FEES IN BALTIMORE CITY.

(1) IN BALTIMORE CITY, THE CLERKS OF THE SEVERAL COURTS OF THE SUPREME BENCH OF BALTIMORE CITY SHALL TRANSMIT ON A ~~[[QUARTERLY]]~~ MONTHLY BASIS ALL APPEARANCE FEES COLLECTED UNDER THE PROVISIONS OF SUBSECTION (A) TO THE LIBRARY COMPANY OF THE ~~[[BALTIMORE]]~~ BALTIMORE BAR TO BE USED FOR THE GENERAL PURPOSES OF THE BAR LIBRARY.

(2) THE LIBRARY COMPANY SHALL FILE AN ANNUAL FINANCIAL REPORT WITH THE DIRECTOR OF THE ADMINISTRATIVE OFFICE OF THE SUPREME BENCH OF BALTIMORE CITY AND WITH THE DIRECTOR OF FINANCE OF BALTIMORE CITY.

(3) BALTIMORE CITY AND COURT EMPLOYEES MAY USE THE LIBRARY IN CONNECTION WITH OFFICIAL DUTIES WITHOUT CHARGE.

(C) DISTRIBUTION OF APPEARANCE FEES IN CARROLL COUNTY.

IN CARROLL COUNTY, THE CLERK OF THE CIRCUIT COURT SHALL RETAIN ALL APPEARANCE FEES COLLECTED UNDER SUBSECTION (A) FOR THE GENERAL USE OF THE COURT LIBRARY OF THE COUNTY INCLUDING EXPENSES FOR BOOKS AND LIBRARY EQUIPMENT.

(D) DISTRIBUTION OF APPEARANCE FEES IN HARFORD COUNTY.

IN HARFORD COUNTY, THE CLERK OF THE CIRCUIT COURT SHALL RETAIN 40 PERCENT OF ALL APPEARANCE FEES COLLECTED UNDER SUBSECTION (A) FOR THE GENERAL USE OF THE COURT LIBRARY OF THE COUNTY, INCLUDING THE NECESSARY EXPENSES FOR BOOKS AND LIBRARY EQUIPMENT AND THE COST FOR THE SERVICES OF A LIBRARIAN.

(E) DISTRIBUTION OF APPEARANCE FEES IN QUEEN ANNE'S COUNTY.

IN QUEEN ANNE'S COUNTY, THE CLERK OF THE CIRCUIT COURT SHALL RETAIN ALL APPEARANCE FEES COLLECTED UNDER SUBSECTION (A) FOR PURCHASING AND MAINTAINING LEGAL PUBLICATIONS RECOMMENDED FOR PURCHASE BY THE QUEEN ANNE'S COUNTY BAR ASSOCIATION AND APPROVED BY THE COUNTY ADMINISTRATIVE JUDGE, EXCEPT COURT REPORTS, CODES OF LAWS, DIGESTS, INDICES OR ANNOTATIONS OF CASES, OR LEGAL ENCYCLOPEDIAE.
