

ANY TIME DURING THE YEAR FOR WHICH THE STATEMENT IS FILED AN INTEREST OF THE PERSON MAKING THE STATEMENT.

(C) ANY INTEREST HELD BY A TRUST, OTHER THAN A COMMON TRUST FUND, UNDER WHICH TRUST THE PERSON MAKING THE STATEMENT HELD A REVERSIONARY INTEREST AT ANY TIME DURING THE YEAR FOR WHICH THE STATEMENT IS FILED [[A REVERSIONARY INTEREST]], OR UNDER WHICH TRUST THE PERSON MAKING THE STATEMENT WAS AT ANY TIME DURING THAT YEAR A TRUSTOR, IF A REVOCABLE TRUST, OR A BENEFICIARY.

[[28-7]] 29-7. FINANCIAL DISCLOSURE ADVISORY BOARD.

(A) THERE IS ESTABLISHED THE FINANCIAL DISCLOSURE ADVISORY BOARD. IT SHALL CONSIST OF [[THREE]] FIVE MEMBERS, [[ONE]] TWO APPOINTED BY THE GOVERNOR, ONE APPOINTED BY THE PRESIDENT OF THE SENATE, [[AND]] ONE APPOINTED BY THE SPEAKER OF THE HOUSE OF DELEGATES, AND ONE, WHO SHALL NOT BE A JUDGE, APPOINTED BY THE CHIEF JUDGE OF THE COURT OF APPEALS. ONE APPOINTEE OF THE GOVERNOR SHALL BE FROM THE PRINCIPAL MAJORITY PARTY AND ONE APPOINTEE SHALL BE FROM THE PRINCIPAL MINORITY PARTY. THE BOARD SHALL ELECT ONE OF ITS MEMBERS AS CHAIRMAN. THE MEMBERS SHALL EACH HOLD OFFICE FOR A TERM OF FOUR YEARS, CO-EXTENSIVE WITH THE TERM OF THE GOVERNOR, AND SHALL CONTINUE IN OFFICE UNTIL THEIR RESPECTIVE SUCCESSORS ARE APPOINTED. VACANT POSITIONS ON THE BOARD SHALL BE FILLED PROMPTLY, FOR THE UNEXPIRED TERM THEREOF, BY WHICHEVER APPOINTING AUTHORITY APPOINTED THE MEMBER WHOSE POSITION IS BEING FILLED. MEMBERS OF THE BOARD SHALL BE ELIGIBLE FOR REAPPOINTMENT. NO OFFICER OR EMPLOYEE OF THE STATE OF MARYLAND OR ANY OF ITS SUBDIVISIONS OR CANDIDATE FOR PUBLIC OFFICE SHALL BE ELIGIBLE TO SERVE ON THE BOARD. EACH MEMBER OF THE BOARD SHALL RECEIVE PER DIEM COMPENSATION AS PROVIDED IN THE BUDGET FOR EACH DAY ACTUALLY ENGAGED IN THE DISCHARGE OF THAT MEMBER'S OFFICIAL DUTIES, AS WELL AS REIMBURSEMENT FOR ALL NECESSARY AND PROPER EXPENSES. THE BOARD SHALL HAVE SUCH STAFF AS PROVIDED IN THE BUDGET. MEETINGS SHALL BE HELD AT THE CALL OF THE CHAIRMAN, OR ANY [[TWO]] THREE MEMBERS OF THE BOARD. [[TWO]] THREE MEMBERS SHALL CONSTITUTE A QUORUM AND THE CONCURRENCE OF AT LEAST [[TWO]] THREE MEMBERS SHALL BE REQUIRED FOR ANY ADVISORY DECISION OR OPINION RENDERED BY THE BOARD. WITHIN THIRTY (30) DAYS FROM THE EFFECTIVE DATE OF THIS SUBTITLE, THE GOVERNOR, THE PRESIDENT, [[AND]] THE SPEAKER, AND THE CHIEF JUDGE OF THE COURT OF APPEALS SHALL APPOINT INITIAL MEMBERS TO THE BOARD, TO SERVE UNTIL THE THIRD WEDNESDAY OF JANUARY, 1975.
