THE TERM INCLUDES GARBAGE, RUBBISH, ASHES, INCINERATOR RESIDUE, WASTE WATER TREATMENT RESIDUE, STREET CLEANINGS, DEAD ANIMALS, DEMOLITION AND CONSTRUCTION DEBRIS, HOUSEHOLD APPLIANCES, AUTOMOBILE EDDIES, OFFAL, PAUNCH MANURE, AND SOLID WASTES FROM COMMERCIAL OR INDUSTRIAL ACTIVITIES.

- (O) WASTE WATER PURIFICATION PROJECT.——"WASTE WATER PURIFICATION PROJECT" MEANS THE SERVICES, FACILITIES, CR PROPERTIES USED OR USEFUL OR HAVING PRESENT CAPACITY FOR FUTURE USE IN CONNECTION WITH THE RECEPTION OF LIQUID WASTES FROM THE COLLECTION SYSTEM OF A MUNICIPALITY OR PERSON; SLUDGE OR OTHER POLLUTANTS BEHOVED FROM THE LIQUID WASTES, INCLUDING TREATMENT FACILITIES OF ALL KINDS, AND ALL PROPERTIES AND RIGHTS THEREIN AND APPURTENANCES THERETO.

- (P) WATER SUPPLY PROJECT.—"WATER SUPPLY PROJECT" MEANS ANY SERVICE, FACILITY OR PROPERTY USED, USEFUL, OR HAVING PRESENT CAPACITY FOR FUTURE USE IN CONNECTION WITH WATER SUPPLY AND DISTRIBUTION, INCLUDING ANY WATER TREATMENT FACILITY OR PROPERTY AND RIGHTS THEREIN AND APPURTENANCES THERETO.
