

POSSESSION OF THE PROPERTY CONDEMNED, UPON PAYING TO THE CLERK OF THE COURT THE AMOUNT OF THE AWARD AND ALL COSTS TAXED TO THAT DATE, NOTWITHSTANDING ANY APPEAL OR FURTHER PROCEEDING BY DEFENDANT. AT THE TIME OF THE PAYMENT, THE SERVICE SHALL GIVE ITS CORPORATE UNDERTAKING TO ABIDE BY ANY JUDGMENT IN ANY APPEAL OR FURTHER PROCEEDINGS.

REVISOR'S NOTE: This subsection is new language derived from Article 33B, section 4(h) of the Code, as amended by S.B. 1055, Chapter 470, Acts of 1973. Specific reference to Article 33B is proposed for deletion only to avoid use of internal cross reference which requires future revision. No other intent is meant.

(J) BORROWING MONEY; ISSUING BONDS AND NOTES AND SECURING SAME.—TO BORROW MONEY AND ISSUE BONDS OR NOTES FOR THE PURPOSE OF PAYING ALL OR ANY PART OF THE COST OF ANY ONE OR MORE PROJECTS; TO PROVIDE FUNDS TO BE PAID INTO ANY DEBT SERVICE RESERVE FUND; TO SECURE THE PAYMENT OF THE BONDS OR NOTES OR ANY PART THEREOF BY PLEDGE OR DEED OF TRUST OF ALL OR ANY PART OF ITS REVENUES OR OTHER AVAILABLE MONEY; TO COMBINE PROJECTS FOR FINANCING PURPOSES AND TO MAKE AGREEMENTS WITH OR FOR THE BENEFIT OF THE PURCHASER OR HOLDER OF THE BONDS OR NOTES, WITH THE ISSUE OF THE BONDS OR NOTES, WHETHER ISSUED OR TO BE ISSUED, AS THE SERVICE MAY DEEM ADVISABLE; AND IN GENERAL TO PROVIDE FOR THE SECURITY OF THE BONDS OR NOTES AND THE RIGHTS OF THEIR HOLDERS.

(K) COMBINING PROJECTS.—TO COMBINE, AFTER CONSULTATION WITH THE MUNICIPALITIES AFFECTED, ONE OR MORE WATER SUPPLY, WASTE WATER PURIFICATION, OR SOLID WASTE DISPOSAL PROJECT WITH ANY OTHER PROJECT AS A SINGLE SYSTEM FOR THE PURPOSE OF OPERATION OR FINANCING.

(L) RATES, FEES AND CHARGES.—TO FIX, ALTER, CHANGE, AND COLLECT RATES, FEES, AND CHARGES FOR THE
