(M) RESPONSIBILITY OF SERVICE OF SUPPLY AND DISTRIBUTION OF WATER UNDER FIVE-YEAR PLAN.--WITHIN A WATER SUPPLY SERVICE DISTRICT, THE SERVICE SHALL BE RESPONSIBLE FOR SUPPLY AND DISTRIBUTION OF WATER AS SET FORTH IN THE FIVE-YEAR PLAN.

REVISOR'S NOTE: This subsection was added to Article 33B, section 5(m) of the Code by Chapter 523, Acts of 1972. The only changes made are in style.

3-107. STUDY AND ACQUISITION OF WATER SUPPLY AND WATER WASTE FACILITIES OF JOPPATOWNE UTILITIES CORPORATION.

(A) ON OR BEFORE OCTOBER 1, 1972, THE SERVICE SHALL UNDERTAKE AND COMPLETE A STUDY OF THE PHYSICAL AND OPERATIONAL EFFICIENCY AND ADEQUACY OF THE QUALITY OF THE SERVICE PROVIDED BY THE WATER SUPPLY AND WASTEWATER FACILITIES AND APPURTENANCES OWNED AND OPERATED BY THE JOPPATOWNE UTILITIES CORPORATION, SITUATED AT THE HEADWATERS OF THE GUNPOWDER RIVER IN HARFORD COUNTY. THE STUDY SHALL BE CARRIED OUT IN CONSULTATION AND COOPERATION WITH EVERY AFFECTED UNIT OF HARFORD COUNTY. UPON COMPLETING THE STUDY, EITHER THE SERVICE OR [[THE HARFORD COUNTY METROPOLITAN COMMISSION]] HARFORD COUNTY SHALL TAKE APPROPRIATE ACTION TO ACQUIRE THE WATER SUPPLY AND WASTE WATER SYSTEMS OF THE JOPPATOWNE UTILITIES CORPORATION, WHETHER BY GIFT, PURCHASE, OR CONDEMNATION. THE ACQUISITION MAY INCLUDE ITS REAL AND PERSONAL PROPERTY, RIGHTS, PRIVILEGES, WATERS, STREAMS, EASEMENTS, FRANCHISES, FACILITIES, AND PROPERTY RIGHTS OF ANY KIND WHATSOEVER. IF THE WATER SYSTEM IS ACQUIRED BY CONDEMNATION, THE PROCEEDINGS SHALL BE FILED UNDER THE PROVISIONS OF LAW CONCERNING EMINENT DOMAIN.

(B) IF THE SERVICE ACQUIRES THE WATER SUPPLY AND WASTE WATER FACILITIES OF THE JOPPATOWNE UTILITIES CORPORATION, IT MAY OPERATE WATER SUPPLY AND WASTE WATER SYSTEMS IN THE SAME MANNER AND WITH THE SAME
