3-108. MANDATORY AGREEMENT TO PROVIDE REQUESTED SERVICES.

(A) REQUEST FOR PROJECT.—ANY MUNICIPALITY OR PERSON MAY REQUEST THE SERVICE TO PROVIDE THE WATER SUPPLY, WASTE WATER PURIFICATION OR SOLID WASTE DISPOSAL PROJECTS AUTHORIZED BY THIS SUBTITLE. THE REQUEST SHALL SET FORTH THE TYPE OF PROPOSED PROJECT TO BE FURNISHED AND THE PROPOSED BOUNDARIES OF THE AREA WITHIN WHICH A PROJECT IS REQUESTED.
