SUBTITLE 2. MARYLAND ENVIRONMENTAL TRUST.

3-201. (A) CREATION, CONTINUATION, AND PURPOSE.—THE MARYLAND ENVIRONMENTAL TRUST IS CREATED AND CONTINUED TO CONSERVE, IMPROVE, STIMULATE, AND PERPETUATE THE AESTHETIC, NATURAL, HEALTH AND WELFARE, SCENIC, AND CULTURAL QUALITIES OF THE ENVIRONMENT, INCLUDING, BUT NOT LIMITED TO LAND, WATER, AIR, WILDLIFE, SCENIC QUALITIES, OPEN SPACES, BUILDINGS OR ANY INTEREST THEREIN, AND OTHER APPURTENANCES PERTAINING IN ANY WAY TO THE STATES THROUGH EDUCATIONAL AND OTHER MEANS, THE TRUST SHALL ENCOURAGE AND MOTIVATE THE POPULACE OF THE STATE AND OTHERS TO DO SO, AND PROMOTE CONTINUING INTEREST IN AND THE STUDY OF THESE MATTERS. THE PURPOSE OF THE TRUST IS OF GENERAL BENEFIT TO THE CITIZENS OF THE STATE AND IT IS CHARITABLE IN NATURE.
