4-211. TAXIDERMIST AND FUR-TANNING LICENSE.

(A) TAXIDERMIST AND FUR-TANNING LICENSE REQUIRED. — ANY PERSON DESIRING TO PRACTICE THE ART OF TAXIDERMY OR WHO DESIRES TO MOUNT OR PRESERVE ANY SPECIES OF FINFISH LEGALLY ACQUIRED, FIRST, SHALL APPLY FOR A TAXIDERMIST AND FUR-TANNING LICENSE. A TAXIDERMIST AND FUR — TANNING LICENSE ALSO SHALL PERMIT THE HOLDER TO MOUNT, PRESERVE, OR TAN ANY SPECIES OF WILDLIFE LEGALLY ACQUIRED AS WELL AS FINFISH.

(B) APPLICATION; FEE; ISSUANCE OF LICENSE. — A PERSON DESIRING A TAXIDERMIST AND FUR-TANNING LICENSE ANNUALLY SHALL APPLY ON FORMS THE SECRETARY SUPPLIES AND PAY A \$5 LICENSE FEE. UPON RECEIPT OF THE APPLICATION AND LICENSE FEE, THE SECRETARY MAY ISSUE THE LICENSE PERMITTING THE PRACTICE OF TAXIDERMY OR FUR-TANNING FOR PROFIT AS PROVIDED IN THE LICENSE.

(C) DURATION OF LICENSE. — A TAXIDERMIST AND FUR-TANNING LICENSE SHALL EXPIRE ON JUNE 30 FOLLOWING THE DATE OF ISSUANCE.

(D) LICENSEES REQUIRED TO MAINTAIN RECORDS. — EACH TAXIDERMIST OR FUR-TANNER SHALL KEEP A LEDGER INDICATING THE NUMBER OR QUANTITY AND SPECIES OF FINFISH AND THE COUNTY OR PLACE OF ORIGIN IN WHICH FINFISH WERE CAUGHT, POSSESSED, BOUGHT, SOLD, TRANSPORTED, SHIPPED, STORED, OR USED BY HIM. THE LEDGER ALSO SHALL INCLUDE THE NAME, ADDRESS, AND CURRENT LICENSE NUMBER OF EACH PERSON, FROM WHOM FINFISH WERE PURCHASED WITHIN OR OUTSIDE THE STATE, THE DATE OF PURCHASE, THE QUANTITY OF EACH SPECIES OF FINFISH PURCHASED, THE COUNTY IN WHICH THE FINFISH WERE CAUGHT, IF PURCHASED IN THE STATE. THE LEDGER SHALL COVER ALL TRANSACTIONS FROM DATE OF ISSUANCE OF THE TAXIDERMIST AND FUR-TANNER'S LICENSE UNTIL DATE OF EXPIRATION. IN ADDITION TO ANY OTHER PENALTY PROVIDED BY THIS SUBTITLE, ANY PERSON FAILING TO MAINTAIN A LEDGER REQUIRED BY THIS SUBSECTION OR MAKING FALSE ENTRIES SHALL HAVE HIS LICENSE REVOKED.

(E) LICENSEES SHALL ALLOW INSPECTION OF PREMISES AND RECORDS.— THE LICENSEE SHALL ALLOW ANY NATURAL
