- (C) ANGLER'S LICENSE REQUIRED. ANY PERSON 16 YEARS OF AGE OR OVER SHALL SECURE AN ANGLER'S LICENSE TO FISH IN THE NONTIDAL WATERS OF THE STATE. AN ANGLER'S LICENSE ENTITLES THE HOLDER TO FISH IN THE NONTIDAL WATERS OF THE STATE ONLY DURING THE OPEN SEASON.
- (D) EXEMPTIONS FROM LICENSE REQUIREMENT. AN ANGLER'S LICENSE IS NOT REQUIRED OF THE FOLLOWING:
- (1) THE OWNER OR TENANT OF LAND BORDERING ON NONTICAL WATER, HIS SPOUSE AND CHILDREN, OR THE SPOUSE OF ANY CHILD WHO RESIDES ON THE LAND WITH THE CWNER OR TENANT WHEN HE FISHES IN NONTIDAL WATER ADJOINING HIS LAND;
- (2) ANY CONVALESCENT PATIENT OF A VETERAN'S HOSPITAL HOSPITALIZED FOR A SERVICE CONNECTED DISABILITY WHO FISHES IN NONTICAL WATERS IF THE PATIENT SECURES A PERMIT ISSUED BY A SPECIAL SERVICE OFFICER OF THE AMERICAN RED CROSS UNDER AUTHORITY GRANTED BY THE DEPARTMENT:
- (3) ANY GROUP OF DISABLED OR CONVALESCENT PATIENTS ORGANIZED AND UNDER THE CARE AND SUPERVISION OF THE AMERICAN RED CROSS, WHICH UPON THE REQUEST OF THE AMERICAN RED CROSS, IS AUTHORIZED BY THE DEPARTMENT TO FISH FOR ANY RECREATIONAL PURPOSE IN THE NONTIDAL WATERS: AND
- (4) ANY RESIDENT SERVING IN THE ARMED FORCES OF THE UNITED STATES, WHILE ON LEAVE IN THE STATE, DURING HIS LEAVE PERIOD, IF, WHILE ANGLING, HE POSSESSES A COPY OF HIS OFFICIAL LEAVE ORDERS.
- (F) HOW ANGLER'S LICENSE OBTAINED. A PERSON MAY APPLY FOR AN ANGLER'S LICENSE TO THE CLERK OF THE CIRCUIT COURT FOR ANY COUNTY OR THE CLERK OF THE COURT OF COMMON PLEAS OF PALTIMORE CITY OR TO ANY PERSON DESIGNATED BY THE DEPARTMENT. THE APPLICATION SHALL BE ON A FORM THE DEPARTMENT PREPARES AND SUPPLIES. THE APPLICANT SHALL FILL OUT, SIGN AND SUBMIT THE APPLICATION TO THE COURT CLERK OR PERSON DESIGNATED TO ISSUE AN ANGLER'S LICENSE. A PERSON MAY APPLY BY MAIL.
- (F) CONTENTS OF APPLICATIONS. THE APPLICATION SHALL CONTAIN THE APPLICANT'S NAME, AGE, HEIGHT, OCCUPATION, PLACE OF RESIDENCE, AND SOCIAL SECURITY NUMBER.
