#### 4-606. RECIPROCAL ANGLER'S LICENSE.

(A) RESIDENTS OF VIRGINIA AND WEST VIRGINIA. — A RESIDENT OF VIRGINIA OR WEST VIRGINIA WHO POSSESSES A FISHING LICENSE VALID IN HIS STATE MAY FISH ONLY IN NONTIDAL WATERS OF THE POTOMAC RIVER WITHOUT OBTAINING A MARYLAND ANGLER'S LICENSE. RECIPROCAL FISHING RIGHTS ARE LIMITED TO THE RIVER AND DO NOT EXTEND TO ITS TRIBUTARIES. THIS SUBSECTION IS EFFECTIVE AS TO A RESIDENT OF VIRGINIA OR WEST VIRGINIA ONLY IF HIS STATE ENTERS INTO AND MAINTAINS RECIPROCAL AGREEMENTS WITH THE DEPARTMENT, APPROVED BY THE ATTORNEY GENERAL, WHICH EXTENDS A SIMILAR FISHING PRIVILEGE FROM THE VIRGINIA OR WEST VIRGINIA BANKS OF THE POTOMAC RIVER TO ANY MARYLAND RESIDENT WHO HAS A VALID MARYLAND ANGLER'S LICENSE WITHOUT REQUIRING A VIRGINIA OR WEST VIRGINIA FISHING LICENSE.

(B) RESIDENTS OF PENNSYLVANIA. — ANY RESIDENT OF PENNSYLVANIA WHO POSSESSES A FISHING LICENSE VALID IN THAT STATE MAY FISH ONLY IN THE WATERS OF THE CONOWINGO AND YOUGHIOGHENY RESERVOIRS WITHOUT OBTAINING A MARYLAND ANGLER'S LICENSE. RECIPROCAL FISHING RIGHTS ARE LIMITED TO THESE RESERVOIRS AND DO NOT EXTEND TO THEIR TRIBUTARIES. THIS SUBSECTION IS EFFECTIVE ONLY IF PENNSYLVANIA FIRST ENTERS INTO AND MAINTAINS A RECIPROCAL AGREEMENT WITH THE DEPARTMENT, APPROVED BY THE ATTORNEY GENERAL, WHICH EXTENDS A SIMILAR FISHING PRIVILEGE ON THE PORTION OF THE CONOWINGO AND YOUGHIOGHENY RESERVOIRS LYING WITHIN THE BOUNDARIES OF PENNSYLVANIA TO ANY MARYLAND RESIDENT WHO HAS A VALID STATE ANGLER'S LICENSE WITHOUT REQUIRING A PENNSYLVANIA FISHING LICENSE.

#### 4-607. COMPLIMENTARY ANGLER'S LICENSE.

THE DEPARTMENT MAY ISSUE ANNUALLY A COMPLIMENTARY ANGLER'S LICENSE, TO THE PRESIDENT OF THE UNITED STATES, THE GOVERNOR OF ANY STATE, AND ANY OFFICIAL OF
