

SHALL BE ALLOWED EXTRA CAR MILEAGE AND OUT-OF-COUNTY MILEAGE AT THE RATE OF 14 CENTS PER MILE. THIS MILEAGE ALLOWANCE SHALL NOT BE PAYABLE IF THE SHERIFF'S OFFICE IS FURNISHED WITH AUTOMOBILES.

(3) THE SHERIFF SHALL BE REIMBURSED FOR THE EXPENSES OF BOARDING PRISONERS COMMITTED TO THE COUNTY JAIL, TO BE PAID MONTHLY UPON VOUCHERS SUBMITTED BY HIM TO THE COUNTY COMMISSIONERS OF GARRETT COUNTY. HE SHALL ALSO SUBMIT WITH THESE VOUCHERS AN AFFIDAVIT SWORN TO BY HIM UPON PERSONAL KNOWLEDGE SHOWING FOR EACH DAY OF THE MONTH JUST PASSED THE NUMBER OF PRISONERS BOARDED BY HIM. THE SHERIFF MAY APPOINT A COOK FOR THE JAIL WHO SHALL RECEIVE A SALARY OF AT LEAST \$2,400. THE SHERIFF, DEPUTIES, AND COOK SHALL EACH RECEIVE AN ADDITIONAL ALLOWANCE OF \$200 DOLLARS PER YEAR FOR UNIFORMS AND CLEANING.

(N) HARFORD COUNTY.

THE SHERIFF OF HARFORD COUNTY SHALL RECEIVE A SALARY OF \$22,000. HE SHALL APPOINT THE NUMBER OF DEPUTIES AT THE COMPENSATION PROVIDED IN THE COUNTY BUDGET.

(O) HOWARD COUNTY.

THE SHERIFF OF HOWARD COUNTY SHALL RECEIVE A SALARY OF \$10,500. HE SHALL APPOINT THE NUMBER OF DEPUTIES AUTHORIZED BY THE COUNTY COMMISSIONERS. THE COMPENSATION OF THE DEPUTIES SHALL BE SET BY THE COUNTY COMMISSIONERS. A DEPUTY HOLDS OFFICE AT THE PLEASURE OF THE SHERIFF AND MAY BE REMOVED BY THE SHERIFF AT ANY TIME OR BY THE CIRCUIT COURT FOR HOWARD COUNTY UPON INDICTMENT AND CONVICTION AS PROVIDED BY LAW. THE SHERIFF MAY APPOINT ADDITIONAL TEMPORARY DEPUTY SHERIFFS WHEN NECESSARY FOR THE PUBLIC SAFETY AND THE COUNTY COMMISSIONERS SHALL ALLOW THEM REASONABLE COMPENSATION. THESE DEPUTIES SHALL NOT SERVE LONGER THAN THE CASE ACTUALLY REQUIRES.

(P) KENT COUNTY.

(1) THE SHERIFF OF KENT COUNTY SHALL RECEIVE A SALARY OF \$8,000 AND \$750 ANNUALLY TOWARD AN AUTOMOBILE TO BE USED BY HIM AND HIS DEPUTIES FOR GENERAL WORK OF THE OFFICE IF AUTHORIZED BY THE COUNTY COMMISSIONERS. HE MAY APPOINT NOT MORE THAN TWO DEPUTIES WHO SHALL RECEIVE SALARIES OF \$5,500. THE SHERIFF AND HIS DEPUTIES SHALL RECEIVE AN ALLOWANCE
