

PLACES OF CONFINEMENT AND STATE INSTITUTIONS IN THE STATE UNDER SENTENCE OR ORDER OF AN AUTHORITY.

(3) BEFORE ASSUMING THE DUTIES OF THE OFFICE, EACH DEPUTY SHERIFF APPOINTED UNDER THIS SUBSECTION SHALL GIVE BOND TO THE SHERIFF IN THE PENALTY OF \$5,000. THE PREMIUMS OF THE BOND SHALL BE PAID BY THE COUNTY.

(T) ST. MARY'S COUNTY.

THE SHERIFF OF ST. MARY'S COUNTY SHALL RECEIVE A SALARY OF \$12,000 AND NO EXPENSE ALLOWANCE. HE SHALL HAVE THE NUMBER OF DEPUTIES PROVIDED FOR IN THE PUBLIC LOCAL LAWS OF ST. MARY'S COUNTY.

(U) SOMERSET COUNTY.

(1) THE SHERIFF OF SOMERSET COUNTY SHALL RECEIVE A SALARY OF \$7,000 AND NO EXPENSE ALLOWANCE. HE SHALL APPOINT AT LEAST TWO DEPUTIES, ONE OF WHOM SHALL BE THE CHIEF DEPUTY AND SHALL RECEIVE A SALARY OF \$5,500. THE SECOND DEPUTY SHALL RECEIVE A SALARY OF \$2,700. THE SHERIFF MAY APPOINT ADDITIONAL DEPUTIES AT THE COMPENSATION APPROVED BY THE COUNTY COMMISSIONERS. THE SHERIFF OR ONE OF HIS DEPUTIES SHALL ACT AS COUNTY JAILER AND SHALL RECEIVE ANNUAL TOTAL COMPENSATION OF \$6,000.

(2) THE SHERIFF AND HIS DEPUTIES SHALL WEAR UNIFORMS WHEN PERFORMING THEIR OFFICIAL DUTIES, AND THE AUTOMOBILES USED BY THE SHERIFF'S OFFICE SHALL BE EQUIPPED WITH A TWO-WAY RADIO.

(3) THE COUNTY COMMISSIONERS MAY PAY FOR THE UNIFORMS, RADIOS, AUTOMOBILES, AND OPERATING EXPENSES OF THE AUTOMOBILES OF THE SHERIFF'S OFFICE.

(V) TALBOT COUNTY.

THE SHERIFF OF TALBOT COUNTY SHALL RECEIVE A SALARY OF \$10,000 AND HE MAY RECEIVE NO OTHER COMPENSATION, DIRECTLY OR INDIRECTLY, FROM THE COUNTY OR ANY OTHER POLITICAL SUBDIVISION. HE MAY APPOINT, SUBJECT TO THE APPROVAL OF THE COUNTY COMMISSIONERS, THE NUMBER OF DEPUTIES HE DEEMS NECESSARY AT THE COMPENSATION FIXED BY THE COUNTY COMMISSIONERS PRIOR TO THE APPOINTMENT. THE SHERIFF'S OFFICE SHALL BE OPERATED ON A 24-HOUR DAILY BASIS.

(W) WASHINGTON COUNTY.
