EVERY CATCH RECORD OR OTHER INFORMATION THE DEPARTMENT REQUIRES BY RULE OR REGULATION.

(C) TEMPORARY LICENSE; DISPOSITION OF FEES. — UPON RECEIPT OF THE REQUIRED FEE, THE COURT CLERK SHALL GIVE THE APPLICANT A DUPLICATE COPY OF THE APPLICATION, WHICH SERVES AS A TEMPORARY LICENSE FOR 15 DAYS TO CATCH CRABS. AFTER ISSUING THE TEMPORARY LICENSE, THE COURT CLERK SHALL FORWARD, WITHIN 48 HOURS, THE ORIGINAL COPY OF THE APPLICATION TO THE DEPARTMENT. THE DEPARTMENT, BY FIRST—CLASS MAIL, SHALL SEND THE LICENSE TO THE APPLICANT. THE COURT CLERK SHALL FORWARD MCNTHLY TO THE DEPARTMENT THE FEES RECEIVED FROM APPLICANTS FOR DEPOSIT TO THE CREDIT OF THE FISHERIES RESEARCH AND DEVELOPMENT FUND.

4-807. CRAE PACKER'S OR SHIPPER'S LICENSES.

- (A) LICENSE REQUIRED. ANY PERSON DESIRING TO ENGAGE IN THE BUSINESS OF PICKING, CANNING, OR PACKING CRABS FIRST SHALL OBTAIN A CRAB PACKER'S OR SHIPPER'S LICENSE.
- WHERE LICENSE OBTAINED: FEES. - THE CRAB PACKER'S OR SHIPPER'S LICENSE MAY BE OBTAINED FROM THE CLERK OF THE CIRCUIT COURT FOR THE COUNTY IN WHICH THE PERSON RESIDES OR DOES BUSINESS, OR FROM THE CLERK OF THE COURT OF COMMON FLEAS IF THE PERSON RESIDES OR DOES BUSINESS IN BALTIMORE CITY. THE LICENSE FEE FOR EVERY PERSON ENGAGED IN THE BUSINESS OF PICKING. PACKING, OR SHIPPING COOKED CANNING, HARD OR SOFT CRAB MEAT, EXCEPT A PERSON PICKING AND CRABS OR SELLING CRAB MEAT FOR LOCAL FAMILY TRADE, IS \$10. THE LICENSE FEE FOR EVERY PERSON ENGAGED IN THE BUSINESS OF COMMERCIALLY BUYING AND SELLING, OR SHIPPING LIVE HARD OR SOFT CRABS, IS \$5.
- (C) DURATION OF LICENSE. EVERY CRAB PACKER'S OR SHIPPER'S LICENSE IS VALID FOR THE YEAR IT IS ISSUED.
- (D) EFFECT OF LICENSE. A PERSON LICENSED TO SHIP OR PACK CRABS IS NOT REQUIRED TO PROCURE ANY FURTHER LICENSE.
