SUBTITLE 9. LOBSTER AND TERRAPIN.

[[4-901. PROVISIONS OF THIS SUBTITLE SUBJECT TO MODIFICATION BY RULE OR REGULATION.

NOTWITHSTANDING ANY PROVISION OF THIS SUBTITLE, THE SECRETARY MAY ADOPT PURSUANT TO THE PROCEDURES ESTABLISHED BY §4-701, RULES AND REGULATIONS RELATING TO CATCHING, POSSESSING, SELLING, PURCHASING, TRANSPORTING, OR EXPORTING ANY LOBSTER. THE RULES AND REGULATIONS MAY INCLUDE, BUT ARE NOT LIMITED TO, PROVISIONS TO ENLARGE, EXTEND, RESTRICT, PROHIBIT CATCHING, POSSESSING, SELLING, PURCHASING, TRANSPORTING OR EXPORTING ANY OYSTERS OR CLAMS. THIS AUTHORITY AND ANY RULE OR REGULATION PROMULGATED UNDER IT SHALL TERMINATE JULY 1, 1973.]

[[4-902.]] 4-901. CATCHING, SELLING, POSSESSING CERTAIN SIZES OF LOBSTER PROHIBITED.

A PERSON MAY NOT POSSESS, SELL, CFFER TO SELL, OR TRANSPORT ANY EGG BEARING OR SCRAPED LOBSTER OR ANY LOBSTER MEASURING LESS THAN THREE AND ONE-EIGHTH INCHES FROM THE REAR END OF THE EYE SOCKET ALONG A LINE PARALLEL TO THE CENTER LINE OF THE BODY SHELL (CARAPACE).
