PART II. DUTIES OF BAILROADS.

5-707. PAILROADS TO CLEAR AND MAINTAIN SAFETY STRIPS.

- IN GENERAL .--- FETWEEN OCTOBER 1 AND APRIL (A) 15, EVERY PERSON WHO OPERATES A PAILPOAD IN THE STATE SHALL FSTABLISH A MEANS TO PREVENT A FOREST FIRE ALONG THE PARTS OF ITS TRACKS ADJACENT TO WHICH DEPARTMENT FINDS A FIRE HAZARD EXISTS OR PROBABLY MAY BE CAUSED BY FAILURE TO TAKE PRECAUTIONS. IF DEPARTMENT BELIEVES CTHER PRECAUTIONARY MEANS APE INSUFFICIENT, THE PERSON SHALL CLEAR A SAFETY STRIP OF A WIDTH NOT EXCEEDING 100 FEET, AS THE DEPARTMENT DETERMINES, MEASURED HORIZONTALLY FROM THE OUTER RAIL. THE SAFETY STRIP SHALL BE CLEARED BY REMOVING ALL DEAD FALLEN LEAVES, WITHERED GRASS, AND INFLAMMABLE MATERIAL, EXCEPT FENCES, BUILDINGS, AND MANUFACTURED PRODUCTS, FROM THE GROUND EMBRACED WITHIN THE WIDTH PRESCRIBED. THIS SUBSECTION DOES PREVENT THE PERSON FROM PILING AND STORING ALONG ITS PIGHT-OF-WAY ANY MATERIALS NECESSARY FOR CONSTRUCTION. MAINTENANCE, OF OPERATION OF ITS RAILROAD.
- (B) NOTIFICATION BY DEPAPTMENT.—BY SEPTEMBER 1 OF EACH YEAR, THE DEPARTMENT SHALL NOTIFY THE PERSON WHO OPERATES A RAILPOAD IN THE STATE OF THE PARTS OF ITS TRACKS WHERE A FIRE HAZARD EXISTS OR PROBABLY MAY BE CAUSED TO EXIST BY FAILURE TO TAKE PRECAUTIONS, OR OF THE NECESSITY FOR A SAFETY STRIP.
 - PEVISOR'S NOTE: This section 5-707 is new language derived from Article 66C, sections 376 and 382 of the Code, as amended by Chapter 801, H.B. 778, Acts of 1973, which are proposed for deletion. The substance of these two sections is set forth in proposed section 5-707(a) and (b). Language is added to provide that this section applies to any railroad operated in the State, not merely to those operated "by other than steam motive power."
