5-1004. OLD FORT FREDERICK: REFORESTATION PROGRAM.

THE TRACT OF IAND IN WASHINGTON COUNTY ON WHICH IS SITUATED OLD FORT FREDERICK, TOGETHER WITH OTHER ADDITIONAL LAND ADJACENT THERETO WHICH HAS BEEN ACQUIRED BY THE STATE IS UNDER THE CONTROL OF THE DEPARTMENT, AND SHALL BE USED IN THE EXECUTION OF THOSE PLANS ADOPTED BY IT FOR REFORESTATION OF THE STATE.

REVISOR'S NOTE: This section presently appears as Article 66C, section 371 of the Code. This section is redrafted since the land in question has been purchased by the State. The final sentence has been repealed, as obsolete, because the money in question appropriated to the department was for the purposes of purchasing the property; this has been confirmed by the department. The only other changes made are in style.

5-1005. AUXILIARY STATE FOREST RESERVES.

THE DEPARTMENT MAY ACCEPT THE USE OF LAND TO BE USED FOR AUXILIARY STATE FOREST RESERVES AND ENTER INTO AGREEMENTS WITH THE OWNERS AS NECESSARY. THE LAND IS SUBJECT TO ALL LAWS, RUIES, AND REGULATIONS GOVERNING STATE FOREST RESERVES. HOWEVER, NO MONEY APPROPRIATED TO THE DEPARTMENT MAY BE USED OR EXPENDED ON AUXILIARY STATE FORESTS FOR PERMANENT IMPROVEMENTS OF FOR ANY PURPOSE OTHER THAN SUPERVISION, OPENING OF TRAILS, THE BUILDING OF TEMPORARY STRUCTURES TO MAKE THE LAND AVAILABLE FOR CAMPERS AND VISITORS, AND PROTECTION OF THE LAND FROM FIRE AND TRESPASS.

5-1006. FREE ADMISSION TO STATE PARKS FOR SCOUT GROUPS AND CAMP FIRE GIRLS ACCOMPANIED BY ADULT LEADER.

YOUTH GROUPS REGISTERED WITH THE SECRETARY SHALL BE ADMITTED TO ANY MARYLAND STATE PARK FREE OF ANY ADMISSION OR OVERNIGHT CAMPING CHARGE. THIS EXEMPTION SHALL APPLY ONLY WHEN THE GROUP IS PARTICIPATING IN OFFICIAL ACTIVITIES UNDER ADULT SUPERVISION. FOR THE PURPOSE OF THIS SECTION YOUTH GROUP INCLUDES, BUT IS NOT LIMITED TO FOY SCOUTS, GIRL SCOUTS, 4—H MEMBERS, AND OTHER AFFILIATED GROUPS. THE SECRETARY MAY
