CONSTRUCTED OF TWO INCH HARDWOOD OR ITS EQUIVALENT. EACH METAL MAGAZINE SHALL BE LINED WITH NONSPARKING MATERIAL. NO MAGAZINE MAY BE PLACED IN A BUILDING CONTAINING OIL, GREASE, GASOLINE, WASTE PAPER, OR OTHER HIGHLY FLAMMABLE MATERIAL, NOR MAY IT BE PLACED LESS THAN 20 FEET FROM A STOVE, FURNACE, OPEN FIRE, OR FLAME.
