HOUSE BILL NO. 15—By the Speaker (Administration):

For the purpose of requiring the periodic disclosure of certain assets, liabilities, income, gifts, and other interests by certain State officials and certain candidates for State office, creating the Financial Disclosure Advisory Board and providing for its composition, powers, and responsibilities, providing for the enforcement of disclosure requirements, [requesting]] directing the Court of Appeals to require disclosure by judges of the State courts [authorizing]] directing the political subdivisions to enact public financial disclosure requirements for certain officials, authorizing the Governor to extend by Executive Order certain disclosure requirements to certain appointed persons, and relating generally to public financial disclosure.

Which was read the first time and referred to the Committee on Judicial Proceedings.
