House Bill No. 1592—By Delegates Walters and Freeberger :

An Act to repeal **[[Sections 46 and]]** Section 46A of Article 89B of the Annotated Code of Maryland (1969 Replacement Volume), title "State Roads," subtitle "Distribution and Use of Special Funds," **[[and to enact in lieu thereof new Section 46, to stand in the same place of the sections so repealed, defining the duties and powers of State Highway Administration employees in respect of law enforcement.]]** and to add new subsection 208C(d) to Article 41 of the Annotated Code of Maryland (1971 Replacement Volume and 1972 Supplement), title "Executive and Administrative Departments," subtitle "Department of Transportation," to follow immediately after subsection 208C(c) thereof, to provide authority to contract for, or to provide and maintain, with respect to the facilities and property owned, leased, operated or under the control of the Authority, a security force, and to define the powers, duties and jurisdiction of such force.
