"(D) THE LOAN HAS NOT BEEN MADE PRIOR TO THE EFFECTIVE DATE OF THIS ACT, AND NO WRITTEN COMMITMENT HAS BEEN ISSUED BY THE LENDER PRIOR TO THE EFFECTIVE DATE OF THIS ACT AGREEING TO MAKE THE LOAN AT A RATE OF 8% OR LESS. A WRITTEN COMMIT-MENT, WRITTEN OFFER TO LOAN, OR ANY OTHER WRITTEN STATEMENT BY A LENDER WHICH CAN BE REASONABLY CONSTRUED AS AN OFFER TO MAKE A LOAN AT ANY SPECI-FIED OR UNSPECIFIED INTEREST RATE IS DEEMED TO BE A COMMITMENT TO MAKE THE LOAN AT 8%, OR LESS, IF SPECIFIED: PROVIDED THAT THE WRITTEN COMMITMENT OR WRITTEN OFFER IS ISSUED PRIOR TO THE EFFECTIVE DATE OF THIS ACT.'

Amendment No. 9—

In line 7 of Section 2 on page 2 of the first reader after "2." insert the following:

"AND BE IT FURTHER ENACTED, THAT IF ANY PROVI-SION OF THIS ACT OR THE APPLICATION THEREOF TO ANY PERSON OR CIRCUMSTANCE IS HELD INVALID FOR ANY REASON, THE INVALIDITY SHALL NOT AFFECT THE OTHER PROVISIONS OR ANY OTHER APPLICATION OF THIS ACT WHICH CAN BE GIVEN EFFECT WITHOUT THE INVALID PRO-VISIONS OR APPLICATION, AND TO THIS END ALL THE PRO-VISIONS OF THIS ACT ARE DECLARED TO BE SEVERABLE. SECTION 3."
