AMENDMENTS TO HOUSE BILL NO. 21

Amendment No. 1-

In the title of the printed bill in line 7 after the word "therefor," add the following: "providing for the rate of interest applicable to loans after the expiration of this Act,".

Amendment No. 2-

On page 1 of the printed bill in Section 13 in line 21 immediately prior to the word "ANY" add the letter "(A)"; and on page 2 following line 6 add the following:

"(b) AFTER JUNE 1, 1974, THE INTEREST CHARGED ON ANY LOAN MADE UNDER THE PROVISIONS OF THIS SECTION SHALL REVERT AUTOMATICALLY WITHOUT ANY FURTHER ACTION REQUIRED BY THE BORROWER TO THE RATE OF INTEREST WHICH IS ALLOWABLE UNDER THE PROVISIONS OF SECTION 3 OF THIS ARTICLE."
