ALL OF THE PROVISIONS OF THE FOREGOING SECTIONS, TO THE EXTENT THEY ARE CONSISTENT WITH THIS SECTION, SHALL APPLY TO ANY OWNER, OFFICER, PARTNER, TRUSTEE, PUBLISHER, GENERAL MANAGER, MANAGER, EDITOR, WRITER, COLUMNIST, REPORTER, CORRESPONDENT, ANNOUNCER, BROADCASTER, TECHNICIAN, STAFF MEMBER, AND ANY EMPLOYEE OF (1) ANY NEWSPAPER, MAGAZINE OR PERIODICAL HAVING A CIRCULATION OF 50,000 OR MORE AND PUBLISHED IN MARYLAND, OR OF (2) ANY RADIO OR TELEVISION STATION THAT IS OWNED IN COMMON WITH A NEWSPAPER, MAGAZINE OR PERIODICAL DESCRIBED IN (1) ABOVE, WHO, EITHER ORALLY OR IN WRITING AND DIRECTLY OR INDIRECTLY, CONTRIBUTES TO THE EDITORIAL POLICY OF THE NEWSPAPER, MAGAZINE, PERIODICAL, OR RADIO OR TELEVISION STATION."
