

## Amendment No. 70—

On page CJ 9-5 of the printed bill, Sec. 9-110, in line 7 after the word "STATEMENT" insert the following words: "NOR MAY HE DISCLOSE ANY INFORMATION DERIVED FROM THE PERSON OR MATERIAL IN RENDERING PROFESSIONAL SERVICE".

## Amendment No. 71—

On page CJ 9-7 of the printed bill, Sec. 9-115 strike out lines 2 through 5, inclusive, and insert in lieu thereof the following words:

"WHERE CHARACTER EVIDENCE IS OTHERWISE RELEVANT TO THE PROCEEDING, NO PERSON OFFERED AS A CHARACTER WITNESS WHO HAS AN ADEQUATE BASIS FOR FORMING AN OPINION AS TO ANOTHER PERSON'S CHARACTER SHALL HEREAFTER BE EXCLUDED FROM GIVING EVIDENCE BASED ON PERSONAL OPINION TO PROVE CHARACTER, EITHER IN PERSON OR BY DEPOSITION, IN ANY SUIT, ACTION OR PROCEEDING, CIVIL OR CRIMINAL, IN ANY COURT OR BEFORE ANY JUDGE, OR JURY OF THIS STATE".

## Amendment No. 72—

On page CJ 9-7, Sec. 9-116, of the printed bill, in line 8, after the word "HEIR", insert ", DEVISEE, DISTRIBUTE"; and on the same line, after the second word "OR", insert the following: "BY OR".

## Amendment No. 73—

On page CJ 9-7 of the printed bill, Sec. 9-117, strike out lines 18 through 21, inclusive, and insert in lieu thereof the following words:

"IT IS NOT COMPETENT, IN ANY CASE, FOR ANY PARTY TO THE CAUSE WHO HAS BEEN EXAMINED THEREIN AS A WITNESS, TO CORROBORATE HIS TESTIMONY WHEN IMPEACHED BY PROOF OF HIS OWN DECLARATION OR STATEMENT MADE TO THIRD PERSONS OUT OF THE PRESENCE AND HEARING OF THE ADVERSE PARTY".

## Amendment No. 74—

On page CJ 9-12 of the printed bill, Sec. 9-203(g), in line 18, strike out the words "HAVE AUTHORITY TO".
